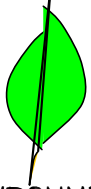

4. The notice of intention to appeal can be submitted for the attention of Mr T. Zwane, Senior Legal Administration Officer (Appeals) as follows:


