## PROPOSED PHOTOVOLTAIC SOLAR ENERGY FACILITY ON THE FARM STRUISBULT NEAR COPPERTON, NORTHERN CAPE PROVINCE (DEA REF. NO.: 12/12/20/2502) NOTIFICATION OF AMENDMENT TO ENVIRONMENTAL AUTHORISATION

Struisbult PV2 (Pty) Ltd obtained authorisation from the National Department of Environmental Affairs (DEA) for the establishment of Proposed Photovoltaic Solar Energy Facility On The Farm Struisbult Near Copperton, Northern Cape Province in January 2013.

The developer requested a non-substantive amendment to the Environmental Authorisation (EA) from DEA. The request for amendment was for the change in the contact person and applicant company name. The EA amendment request has been granted by DEA and is attached to this letter.
