Establishment of a township development at Plot 67, 68, 69 Estoire, Bloemfontein, Free State Province.

The site proposed for development consists of two residences, small scale agriculture including grazing and hay-making. The site also contains areas of remaining natural vegetation. The area will be transformed by construction and the vegetation layer will be removed.

According to the Integrated Development Plan 2013 the site forms part of the Estoire Node earmarked for residential development.

The centre coordinate for the development is S 29° 06' 24.18" and E 26° 16' 24.17".

Water Use:

- The development is situated within the Estoire Small Holdings and will connect to the municipal sewage system. Failing this the residential area will be serviced by means of Lilliput sewage systems.
- The residential development will connect to the municipal potable water system.

Effluent Management:

 No effluent will be produced by the proposed township establishment. Storm water will be managed on a continuous basis.

General waste:

 The area is not currently serviced by the municipal refuse removal but this will be implemented once the development has been completed.

Hazardous waste:

No hazardous substances or wastes will be generated by the township development.

Clearing of vegetation:

Vegetation will be cleared from the footprint of the residential development.
