GLENCORE OPERATIONS SOUTH AFRICA (PTY) LTD NOTICE OF THE APPLICATION FOR AN ENVIRONMENTAL AUHORISATION FOR THE PROPOSED CLEARANCE OF INDIGENOUS VEGETATION FOR THE CREATION OF A PRODUCT STOCKPILE

This letter gives notice to potential Interested and Affected Parties (I&APs) about where information in respect of the application for the clearance of indigenous vegetation for the creation of a tailings storage facility can be obtained, as well as the opportunity I&APs have to comment on the Basic Assessment Report (BAR).

BACKGROUND TO THE PROJECT

Glencore Operations South Africa (Pty) Ltd (Glencore) own and operate the Rietvlei Silica Mine. Rietvlei Mine is an existing mine situated 10 km North West of Rustenburg in the North West Province on portions of the farm Rietvly 271 JQ and Fogwill 324 JQ. The main aim of the operation is to produce silica ore for the ferrochrome furnaces of Xstrata, situated in the Rustenburg area. The silica ore fragments are obtained through blasting, crushing, washing, drying and screening.




Figure 1: Locality Map of the project area

Current mining activities are progressing in an Easterly direction. Therefore, to make way for the continued progression of the Rietvlei Silica Mine, Glencore purchased Portion 103 of the Farm Shylock 256 that is situated adjacent to the current operations. It is proposed that this property will be used for stockpiling silica product. A drainage line is located on the north-eastern portion of the property and the current stockpile is situated within a 100 m of this non-perennial drainage line. Two alternative options for stockpiling at the new property will be investigated within the BAR. Option 1 entails stockpiling the product with an adequate buffer to the existing drainage line. This will slightly decrease the total area available for stockpiling. Option 2 entails diverting the drainage line to the east of the property which will alter the natural state of the drainage line. Which will allow for a larger area available for stockpiling. The project area that is the subject of the application is therefore an area along the western boundary of the mine (Figure 1).

LEGISLATIVE REQUIREMENTS

Procedure applied to the application

As the project activities require the clearance of indigenous vegetation, a Basic Assessment (BA) will be required in compliance with:

 the National Environmental Management Act, 1998 (Act No.107 of 1998) (NEMA) for the authorisation of listed activities contained in GNR 983 of 4 December 2014 (GNR 983) as amended, published in terms of Sections 24(2), 24 (5), 24D, 44 and 47(A) (1)(b) of the NEMA.

Application submitted to competent authority

An application for authorisation in terms of the NEMA, as amended and the Environmental Impact Assessment Regulations, 2014, will be submitted to the Department of Mineral Resources (DMR) on 30 August 2018.

Project description and Listed activities applied to the application

The project makes provision for:

- the clearance of approximately 12.3Ha of indigenous vegetation.
- stockpiling of product, namely; small chips, large chips, lump and fines.
- protected tree and plant species, and structures and trees older than sixty years will be removed where required.

The listed activities which have been applied for include:

- GNR 983 Listing Notice 1, as amended, Activities 12 and 27 under NEMA
- GNR 985 Listing Notice 3, as amended, Activity 12 (h) (iv and vi) under NEMA

South African legislation requires that a BAR and an Environmental Management Programme Report (EMPr) be compiled in accordance with Regulation 19 of Chapter 4 of GNR 982, as amended. To do so, Shangoni Management Services (Pty) Ltd (Shangoni) has been appointed as the independent Environmental Assessment Practitioner (EAP) in terms of Regulation 12 of GNR 982, as amended, to undertake and manage the processes to apply for the required environmental authorisations. Furthermore, Shangoni meets the requirements of an EAP contemplated in Regulation 13 of GNR 982, as amended.
