Notice is hereby given in terms of the National Environmental Management Act, 1998 (Act No 107 of 1998) as amended and the Environmental Impact Regulations (2010) and National Water Act 36 of 1998 (Act 36 of 1998) that Bold Moves 384 (Pty) Ltd (previously operating as "Solafrica Thermal Energy (Pty) Ltd") has submitted an application for environmental authorisation to the Department of Environment and Affairs

Bold Moves 384 (Pty) Ltd proposes the construction of a 15 km pipeline from farm Sand Draai 391 Portions 0 and 5 to farm Bokpoort 390 Portion 0 near Groblershoop, Northern Cape Province . In order for a proposed (and recently authorised) CSP plant to attain sufficient water for the operation of the cooling system, water must be abstracted from the Orange River and transported to the plant via the proposed pipeline where it will be stored in a storage pond facility and used for the cooling system and other plant water uses.

**Consequently Bold Moves 384 (Pty) Ltd ("Solafrica") has appointed SSI Environmental Consultants to undertake a Basic Assessment Report and Environmental Management Programme respectively as required for the application for environmental authorisation of the proposed project.**
