Notice is hereby given in terms of Regulation 41(2) published in Government Notice No. R.326 under Chapter 6 of the Environmental Impact Assessment Regulations dated 7<sup>th</sup> April 2017, of the intent to compile a Basic Assessment Report and Environmental Management Programme in support of an application for an Environmental Authorization in terms of the National Environmental Management Act, (Act 107 of 1998), as amended.

**Note:** Applications for authorisations (WULA) in terms of the National Water Act, 1998 (Act 36 of 1998), as amended, will also be submitted as guided by the Department: Water and Sanitation.

### **PROJECT PROPOSAL:**

Construct a new section of earth canal  $\pm 230$  m in length linking into the existing Knutsford Irrigation Scheme canal at an existing maintenance sluice and return surplus water into the Great Fish River via a 1900 mm diameter pipe/hydro plant to generate  $\pm 305$  kW power. Construction of the hydro-plant will include excavation of the river embankment, placement of pipe and hydro-plant, associated concrete works, back-filling of excavated material and protection of the "discharge to river" return area and the embankment. An overhead powerline  $\pm 5,5$  km in length will be constructed to distribute <275 kV to 5 existing transformer points on the farm. DWS have advised that a Water Use Licence Application must be submitted in terms of the National Water Act, 1998 (Act. 36 of 1998). Operation will require the opening of 2 existing sluice gates at the Knutsford Irrigation Scheme diversion weir (Katkop Weir) to divert existing surplus overflow ( $\pm 4$  Cumec) into the existing Knutsford Irrigation Scheme canal for a distance of  $\pm 1800$  m, where the new section of canal will be constructed to the hydro-plant.


