AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON 10 FEBRUARY 2017 FOR THE 115 MEGAWATTS (MW) LUTZBURG PHOTOVOLTAIC SOLAR ENERGY FACILITY ON THE REMAINING EXTENT OF PORTION 2 OF THE FARM RUBY VALE NO. 266 SOUTH OF THE TOWN OF OLIFANTSHOEK WITHIN THE TSANTSABANE LOCAL MUNICIPALITY IN THE NORTHERN CAPE PROVINCE
