



Sishen Mine is planning to expand and amend the existing authorised mining and associated activities taking place at the Lylyveld North and Lylyveld South mining areas. 


FIGURE 2: PROPOSED EXPANSIONS AT LYLYVELD NORTH




FIGURE 3: PROPOSED EXPANSIONS AT LYLYVELD SOUTH

3. Environmental Authorisations

3.1 Minerals & Petroleum Resources Development Act (No. 28 of 2008)

The current approved Environmental Management Programme and its subsequent amendments do not provide for the expanded activities at Lylyveld North and South. Section 102 of the Minerals & Petroleum Resources Development Act indicates that an Environmental Management Programme may not be amended without authorisation.

The Environmental Management Programme compiled as part of the supporting documentation for the application for the environmental authorisation also serves as an amendment to the existing <u>authorised</u> management programme and the amendments thereto, in terms of Section 102 of the Minerals and Petroleum Resources Development Act.

3.2 National Environmental Management Act (No. 107 of 1998)

Authorisation is to be sought in terms of Section 24 of the National Environmental Management Act for the proposed activities that may have a detrimental impact on the environment. Activities to be authorised as per those listed in the Environmental Impact Assessment (EIA) Regulations Listing Notices GNR, 983-985 of 4 December 2014 as amended.

Activities in Listing Notices 1 require a Basic Impact Assessment in support of the application for authorisation. Those in Listing Notice 2 require a Scoping and EIA in support of the application.

Since some of the planned activities are included under Listing Notice 2, a Scoping and EIA will be undertaken in support of the application for environmental authorisation.

3.3 National Environmental Management: Waste Act (No. 59 of 2008)

In terms of Section 19 of the National Environmental Management: Waste Act, a list of waste management activities that is likely have a detrimental effect on the environment was promulgated through Regulation GN. 921 (November 2013). The listed activities were amended by GN. 633 of 24 July 2015 to include the development of mine residue dumps. Note that in terms of Schedule 3 of the Act, all mineral residue deposits are regarded as Hazardous Waste.

An application needs to be made to the DMR for a Waste Management Licence to allow for the development or expansion of waste rock dumps. The application is to be supported by a Scoping and EIA Process, Category B activities are triggered.

	Attendees included representatives from Eskom, local business, other environmental practitioners and neighbouring farmers (in particular those that make use of the road to Dingleton to access their farms) Sishen Mine was represented by SS from the Environmental Department		
<u>2.</u>	Purpose of the Meeting		
2.1	KF explained that Sishen Mine has existing environmental authorisations for the current mining operations at Lylyveld South and Lylyveld North. The original authorisation provided for a life of 10 years, which is now nearing an end (2022). Sishen now wishes to extend the life of the operations and this also requires new pits and dumps as well as expansions to existing pits and dumps.		
	EXM has been appointed to act as the independent environmental assessment practitioner responsible for the environmental authorisation process.		
2.2	Such expansions require authorisation by the Department of Mineral Resources (DMR) as well as the Department of Water and Sanitation (DWS). The application for authorisation is to be supported by an environmental impact assessment (EIA) process. The meeting forms part of the public participation process for the EIA. The EIA process is in the scoping phase and the purpose of the meeting was to collate issues and concerns for consideration in the EIA process.		
<u>3.</u>	Locality		
3.1	KF indicated the location of Lylyveld North and South, lying north and south of the N14.		
<u>4.</u>	Project Overview		
4.1	KF explained the planned changes to the existing footprint at Lylyveld North. This includes an expansion of the pit, existing waste rock dumps and stockpile area. A new haul road is to be developed to the pit in the north. A new waste rock dump is to be developed to the pit.		
4.2	AdT indicated that the proposed expansion of the waste rock dumps as indicated will impact on the power line that runs to the east of the project and is also in close proximity to an existing substation to the south east.		
	KF noted this and indicated that the intention was not to impact on infrastructure. This issue will be addressed in the further planning of the project. It is likely that infrastructure will be avoided.		
	AdT indicated it would be in the interest of Eskom to move this substation. He requested that Eskom be informed of the mines planning in the proximity to this infrastructure in order that future planning can be co-ordinated. He noted that there is currently drilling in the area of the substation and if Kumba are planning to mine in the area in the future, it would be good if they were informed by the end of 2018 as this will greatly assist them with their planning.		
4.3	KF explained that mining at Lylyveld South would include expansion of the existing pit as well as the mining of old historical workings. The waste rock dumps will be expanded. Waste rock would also be placed to the east of the existing footprint area. There will also be a new stockpile area.

4.4.	KF explained that they existing haul road will also be widened to facilitate the movement of traffic on the roads. KF indicated that currently there are no plans to expand the mining fleet and the expansion of the haul roads is required to allow vehicles to improve the safety of vehicles passing each other on the road.	
<u>5.</u>	Environmental Authorisations	
5.1	KF explained that authorisation for the amendments is required in terms of the Minerals and Petroleum Resources Development Act, as an addendum to Sishen EMPr. Listed activities need to be approved in terms of the EIA Regulations under the National Environmental Management Act. This includes development of the new haul road, widening of the haul road and clearing of indigenous vegetation.	
	The DMR is also required to authorise the disposal of waste rock under the National Environmental Management: Waste Act.	
	Licensing in terms of the National Water Act is also required for the disposal of waste rock.	
	KF explained that the changes required in the waste rock dumps for the project have been included in a consolidated water use application, which is currently in process.






Figure 1: Layout of Lylyveld Activities, showing no mining activities to take place within 100 m of a railway line or on Transnet's Property
