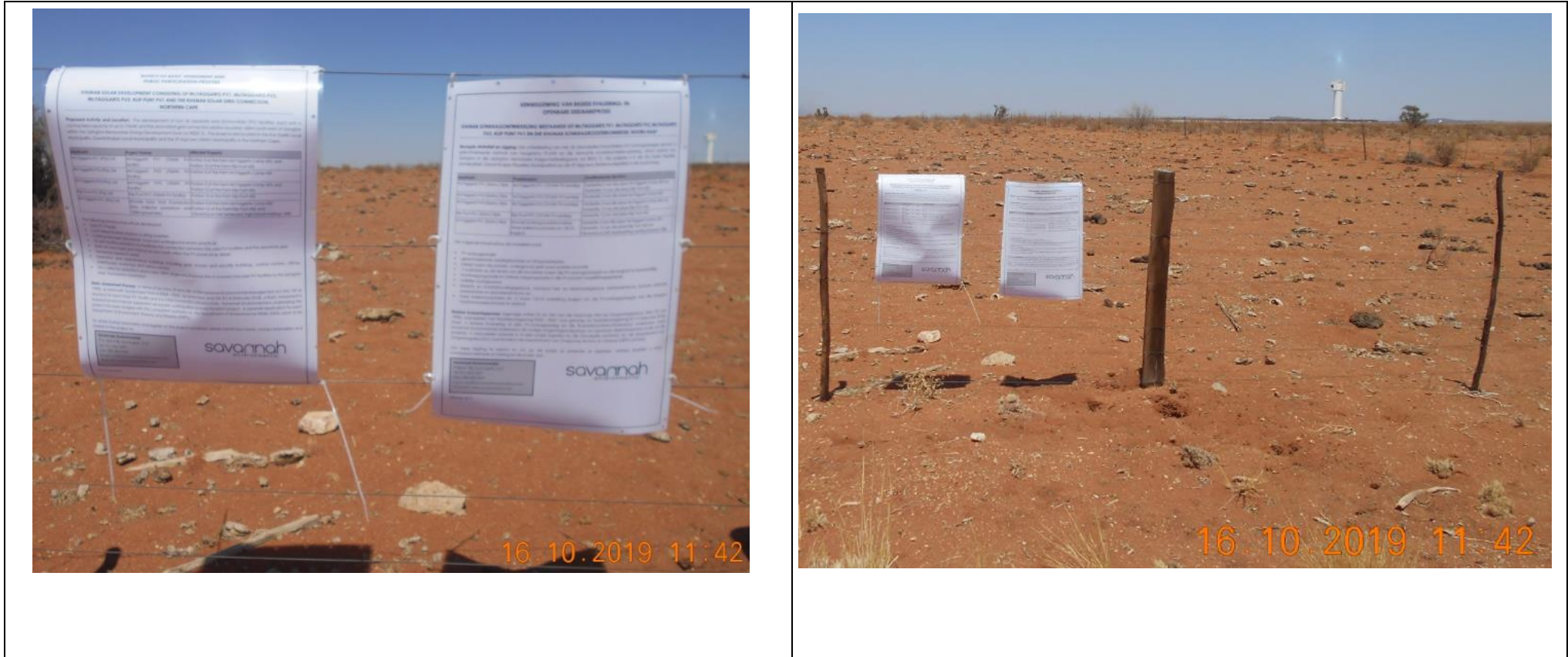

# Boesmanland se boere help

**GEMSBOK-UPINGTON: Boerehulp RSA, 'n vrywillige groepie van die Suid-Kaap wat graag wil uitreik na die boere, die boervrouens en die plaaswerkers wat tans so baie swaar trek in hierdie gewelddige droogtegreep waarin ons land vasgevang is.**

Dit het hulle laat besluit om te begin by een boerevereniging in die Boesmanland, deels omdat daardie streek so ver afgeleë is en deels omdat die koördineerder van Boerehulp RSA al sporadies vir die afgeleë



56 jaar in die Boesmanland kom en hy nog nooit 'n droogte van hierdie intensiteit daar gesien of beleef het nie.

Boerehulp RSA het met die voorsitter van die Nous-Wes boerevereniging, 60km wes van Kakamas, kontak gemaak en die 15 boere van daardie vereniging se aanvanklike primêre behoefte was om 'n voermenger te bekom, sodat hulle die voorreste wat hulle ontvang, eerstens fyn genoeg kon kry vir die skaap om te vreet en tweedens om die regte voermengsels te maak.

Die goedkoopste menging wat hulle kon kry, was 'n kleintjie teen R70 000. Met 'n voermenger kan die boere ook aansienlik bespaar teenoor die koste van aangekoopte voer.

Boerehulp RSA se eerste doelwit was om genoegsame fondse in te samel om so 'n voermenger vir die boerevereniging aan te koop. Gelukkig het een boer van Outeniqualand vir hulle 'n groot komposstrooier geskenk wat tans gratis deur 'n ingenieursfirma op George omskep word in 'n voermenger.

Die materiaal van hierdie menging gaan so in die orde van R20 000 wees en dan moet die menging nog 1000km vervoer word tot in die Boesmanland.

Die boere wag met groot afwagting om hierdie menging in ontvangs te neem. Intussen het hulle al drie vrage mieliereste vanaf Wesselsbron laat aanry vir die boere van Nous-Wes en kon ook onder andere 300 lusernale op Augrabies aankoop.

Boerehulp RSA sal dit verwelkom as daar meer mense is wat betrokke wil raak. Enige hulp word met dank aanvaar. Omdat die afstande so baie ver is, is die vervoerkoste hoog en dit 'n baie groot hap van hul fondse.

## INTERRUPTION OF BULK ELECTRICITY SUPPLY TO NAMA KHOI LOCAL MUNICIPALITY

Eskom hereby notifies all parties who are likely to be materially and adversely affected of its intention to interrupt bulk supply to the Nama Khoi Local Municipality on 21 January 2020 and continue indefinitely.

Nama Khoi Local Municipality is currently indebted to Eskom in the amount of R113 289 157.15 (One hundred and thirteen million, two hundred and eighty nine thousand, one hundred and fifty seven rand and fifteen cents) for the bulk supply of electricity, part of which has been outstanding and in escalation since August 2014 ("the electricity debt").

Eskom Holdings SOC Ltd ("Eskom") is under a statutory obligation to generate and supply electricity to the municipalities nationally on a financial sustainable basis.

Nama Khoi Local Municipality's breach of its payment obligation to Eskom undermines and places in jeopardy Eskom's ability to continue the national supply of electricity on a financial sustainable basis.

In terms of both the provisions of the Electricity Regulation Act 4 of 2006 and supply agreement with Nama Khoi Local Municipality, Eskom is entitled to disconnect the supply of electricity of defaulting municipalities, of which Nama Khoi Local Municipality is one, on account of non-payment of electricity debt.

In order to protect the national interest in the sustainability of electricity supply, it has become necessary for Eskom to exercise its right to disconnect the supply of electricity to Nama Khoi Local Municipality.

Eskom recognises that the indefinite disconnection of electricity supply may cause undue hardship to consumers and members of the community, and may adversely affect the delivery of other services.

In view of this, Eskom is contemplating a regulated interruption of electricity supply as opposed to an outright disconnection. The contemplated regulated interruption will allow members of the community and consumers the opportunity to make alternative arrangements for the scheduled periods of interruption.
