PROJECT TITLE

Proposed Incinerator Replacement, Middelburg, Eastern Cape.

PROJECT DESCRIPTION

The existing incinerator is used for incinerating waste at the Middelburg Veterinary Laboratory but it is more than 30 years old and as a result has become unserviceable. The chimney, burner and brick lining of the incinerator at the Middelburg Laboratory has become unserviceable and needs to be replaced. The electrical burner is not functional and fire is made manually. One of the main objectives of the proposed incinerator upgrade is to ensure that the facility complies with the relevant air quality legislation and standards.

The Middelburg Veterinary Laboratory generates organic waste, general office waste, e.g. paper, glass and medicines during the conduct of diagnostic and analytical testing of specimen of animal origin. The organic waste which includes animal carcasses and tissue samples are disposed of through incineration. Expired foods from nearby supermarkets and police waste are also brought for incineration. The incineration process is carried out by placing the material in the incinerator, adding diesel and igniting the diesel manually as the electrical burner is out of order. There are two 2,000-liter diesel tanks with bund walls adjacent to the incinerator. Incineration is usually conducted once or more times a week depending on the accumulated volume of material for disposal. The resulting ash is placed in containers and will be collected and disposed of via a contractor (e.g. Compass Medical Waste Services) or taken to a suitable waste landfill facility. All other medical wastes, such as petri dishes and sharps, are also collected and disposed of by the approved service provider.

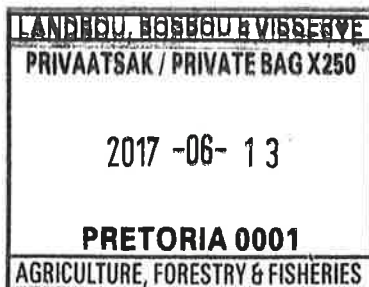

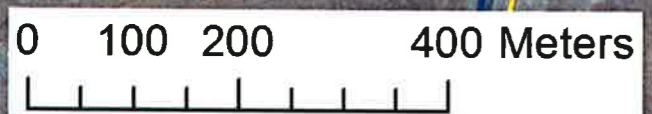

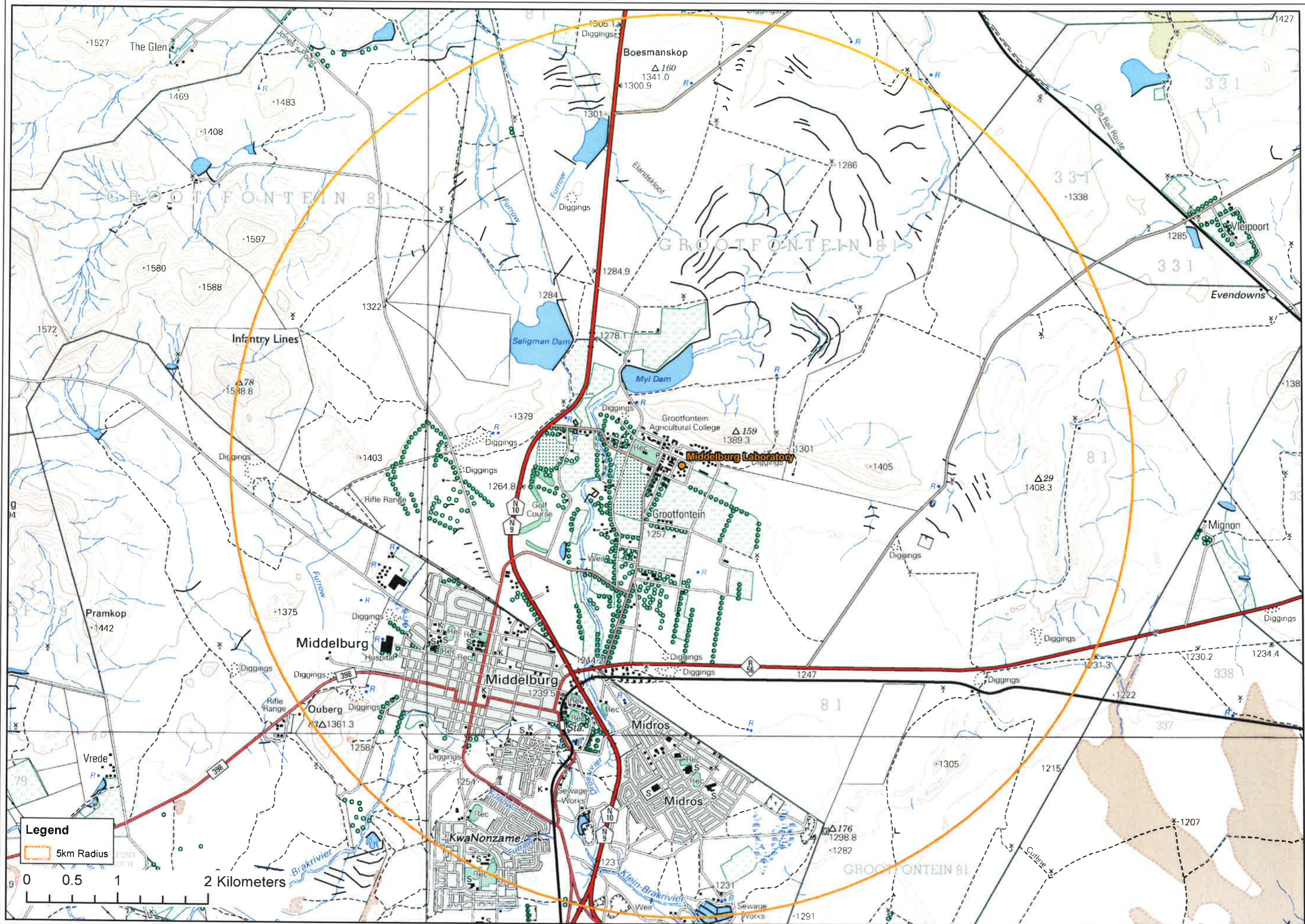
