# Background Information Document for the Proposed "Milky Way Shopping Mall" on Erf 18976, Pinetown, Wiltshire Road, Marianhill

#### THE PROPOSED PROJECT

NS Environmental (Pty) Ltd were appointed by Newlitone (Pty) Ltd to conduct an Environmental Basic Assessment (environmental authorisation) for the proposed construction of Marianhill Mall on Erf 18976, Pinetown, Wiltshire Road located within eThekwini Municipality.

The infrastructure to be established will include approximately 6 000m<sup>2</sup> of line shops, parking, taxi rank and associated infrastructure.

#### PURPOSE OF THIS DOCUMENT

This Background Information Document (BID) provides Interested and Affected Parties (I&APs) with basic project information, as well as information regarding the Basic Assessment and Water Use Licence process being undertaken. It further indicates the important role of public participation during the assessment phase, as input from I&APs contributes to ensuring that all potential issues are considered.

#### LOCALITY

The site is situated approximately 5 km South of Pinetown. Geographical co-ordinates for the study area are (29°51'46.71"S) (30°50'22.18"E). The proposed site is formally described as on Erf 18976, Wiltshire Road, Pinetown.

#### LEGAL FRAMEWORK

According to the National Environmental Management Act (Act no. 107 of 1998), EIA Regulations promulgated on the 4<sup>th</sup> December 2014 a Basic Assessment process must be undertaken for the proposed development. The following listed activities of the 2014 Environmental Impact Assessment Regulations will be applied for:

#### GN R. 983

**19)** The infilling or depositing of any material of more than 10 cubic metres into, or the dredging, excavation, removal or moving of soil, sand, shells, shell grit, pebbles or rock of more than 10 cubic metres from a watercourse.

The development will also require a Water Use License Application (WULA) from the Department of Water & Sanitation (DWS) in terms of Chapter 4 and Section 21 of the National Water Act No. 36 of 1998 for the following water uses:

- Section 21 (c): Impeding or diverting the flow of water in a watercourse; and
- Section 21 (i): Altering the bed, banks, course or characteristics of a watercourse.

**Eco-Pulse Consulting** has been appointed to manage the WULA application. **NS Environmental (Pty) Ltd.** will manage the Basic Assessment process and facilitate the Public Participation Process for both the BA and WULA.

#### **NEED AND DESIRABILITY**

There is a need for a shopping mall in the vicinity of study site. The site is located in Marianhill surrounded by Marian-Ridge, Southmead and Marian-Heights. The proposed shopping mall will service the local community who currently have to travel to Pinetown CBD to access to formal shopping facilities.

The proposed development will also provide employment opportunities for the local community, which will likely stimulate the local economy.

#### PUBLIC PARTICIPATION

Public participation is a process that invites Interested and Affected Parties (I&APs) to submit their comments on the proposed project. I&APs are invited to participate by registering with the Environmental Assessment Practitioner (EAP) undertaking the environmental authorisation process. The public participation process is intended to:


- Provide the public with information on the proposed development
