## BASIC ASSESSMENT PROCESS

Notice is hereby given in terms of Chapter 6 of the Environmental Impact Assessment (EIA) Regulations, 2014, as amended on 7 April 2017, that an application for a **Basic Assessment (BA) process** will be lodged with the Gauteng Department of Agriculture and Rural Development (GDARD), as per the National Environmental Management Act (NEMA), 1998 (Act No. 107 of 1998), as amended.

## HERITAGE IMPACT ASSESSMENT

Notice is hereby given that an application for a **Phase 1 Heritage Impact Assessment (HIA)** in terms of Section 38 of the National Heritage Resources Act (NHRA), 1999 (Act No. 25 of 1999) will be lodged with the Provincial Heritage Resources Authority of Gauteng (PRHA-G).

**Project Name:** Mnandi Filling Station.

### Project & Property Descriptions:

The proposed filling station will be situated on Holding 140, Mnandi Agricultural Holdings Extension 1, Centurion, Gauteng.

**Location:** The proposed filling station is situated on the corner of West and Tulip Street north of the R114. The Copperleaf Golf Estate is located approximately 1 kilometre north-west of the study site. West Road, which forms part of the western boundary of the study site, connects with Emie Els Boulevard which is the main access road to the Copperleaf Golf Estate.
