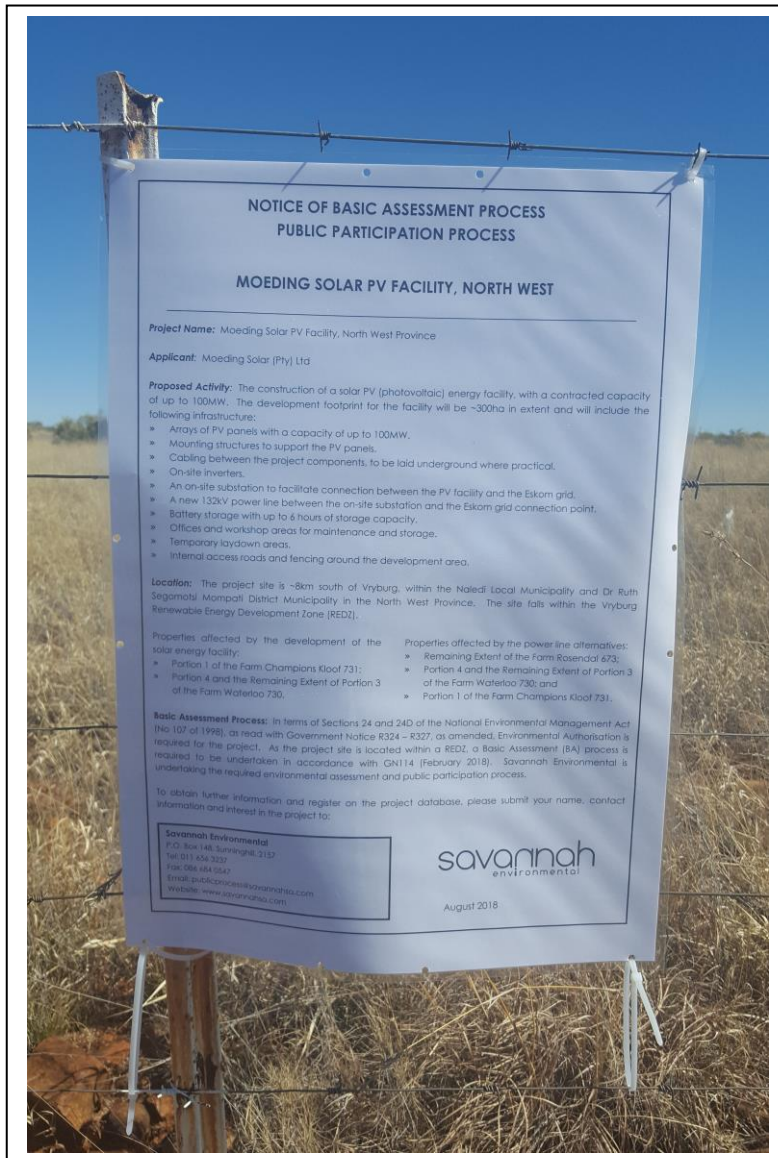


Figure 2: Site notice placed on the boundary fence of Remaining Extent of Farm Rosendal 673 (27°00'34.10"S; 24°44'59.90"E).

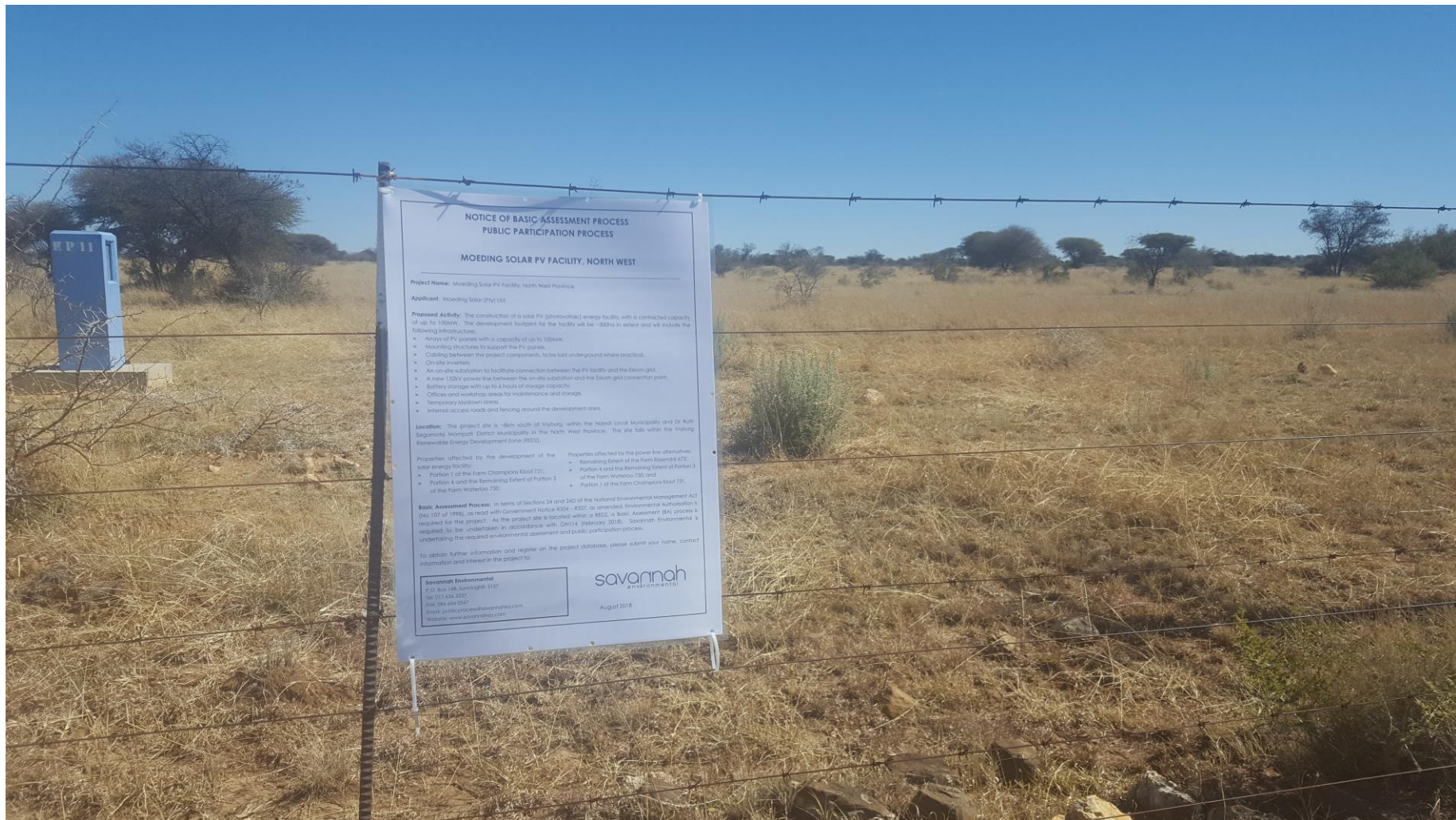


Figure 3: Site notice placed on the boundary fence of the Portion 1 of the Farm Champions Kloof 731 (27°04'12.07"S; 24°45'20.50"E).

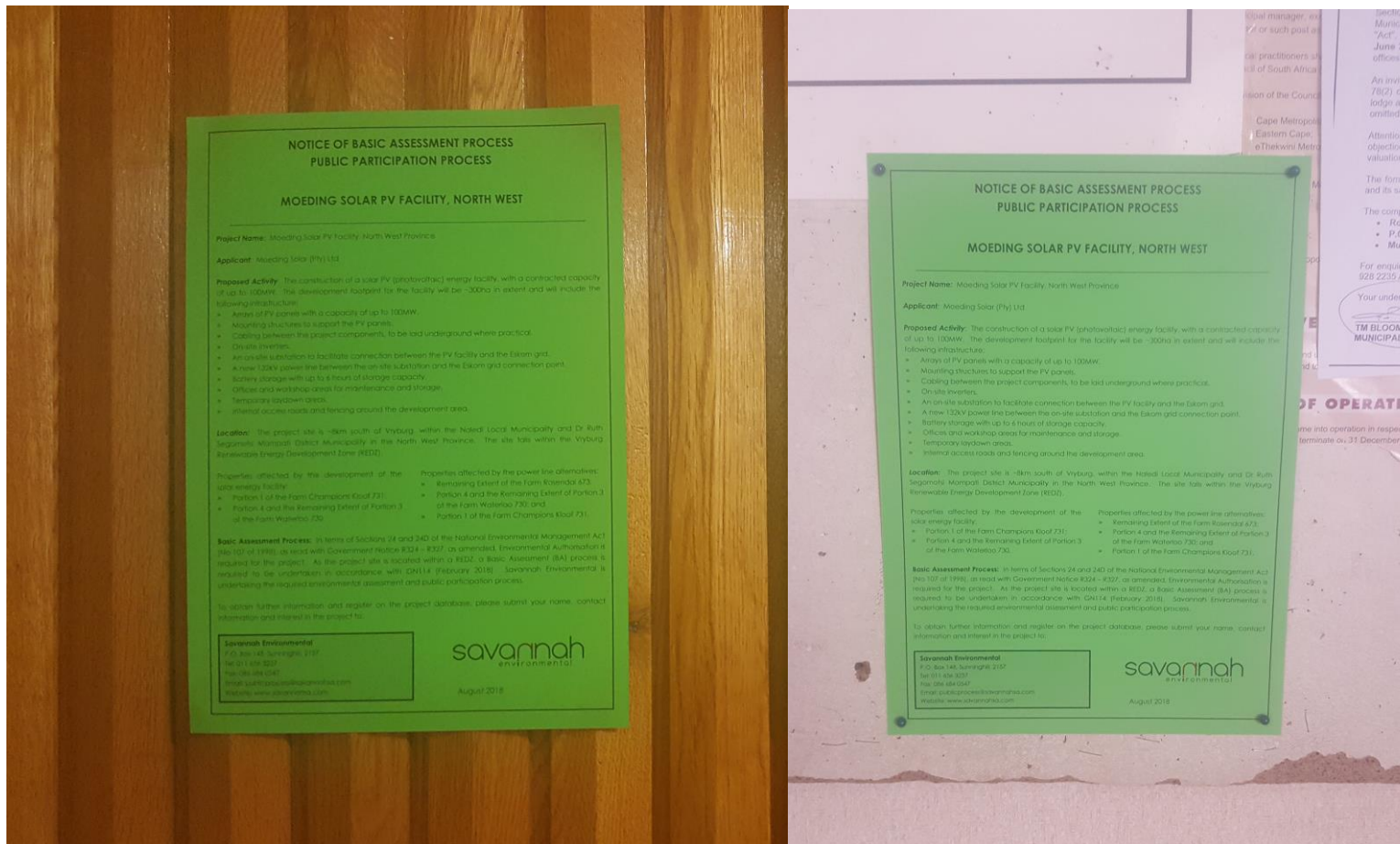


Figure 5: Notices placed at the Naledi Local Municipality (26°57'28.52"S; 24°43'17.96"E).

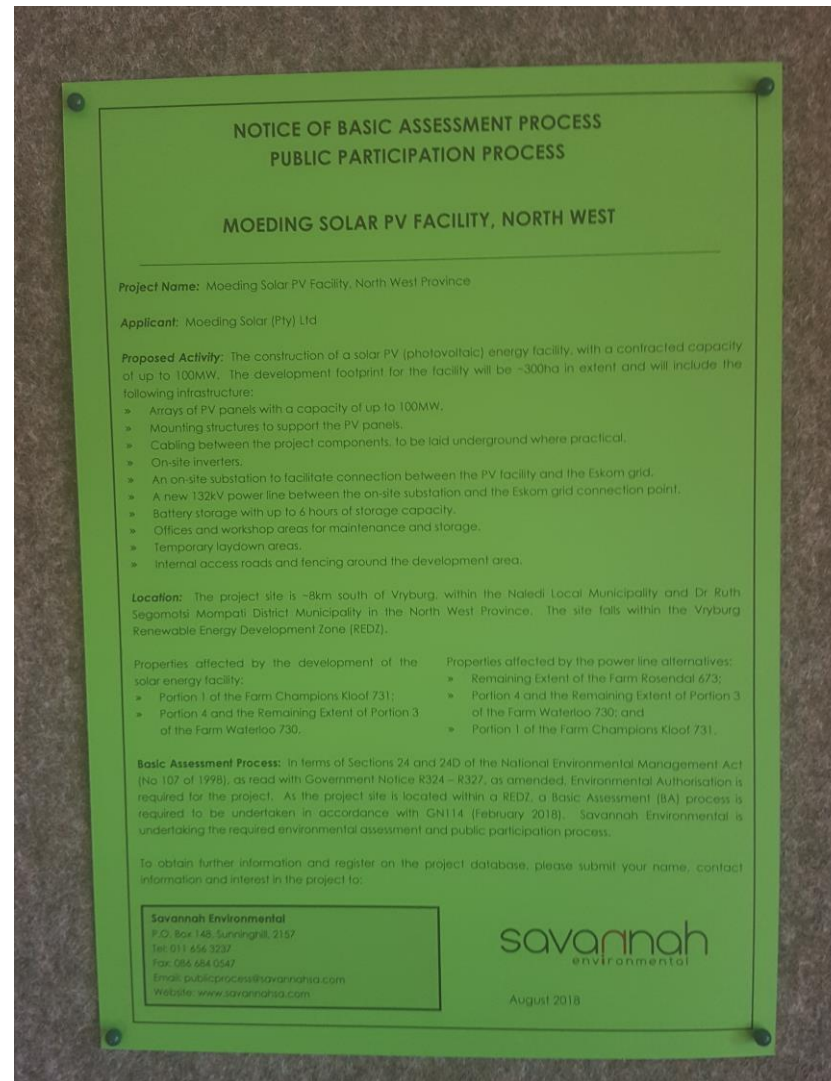


Figure 6: Notice placed at the Huhudi Public Library (26°58'29.64"S; 24°44'23.0"E).

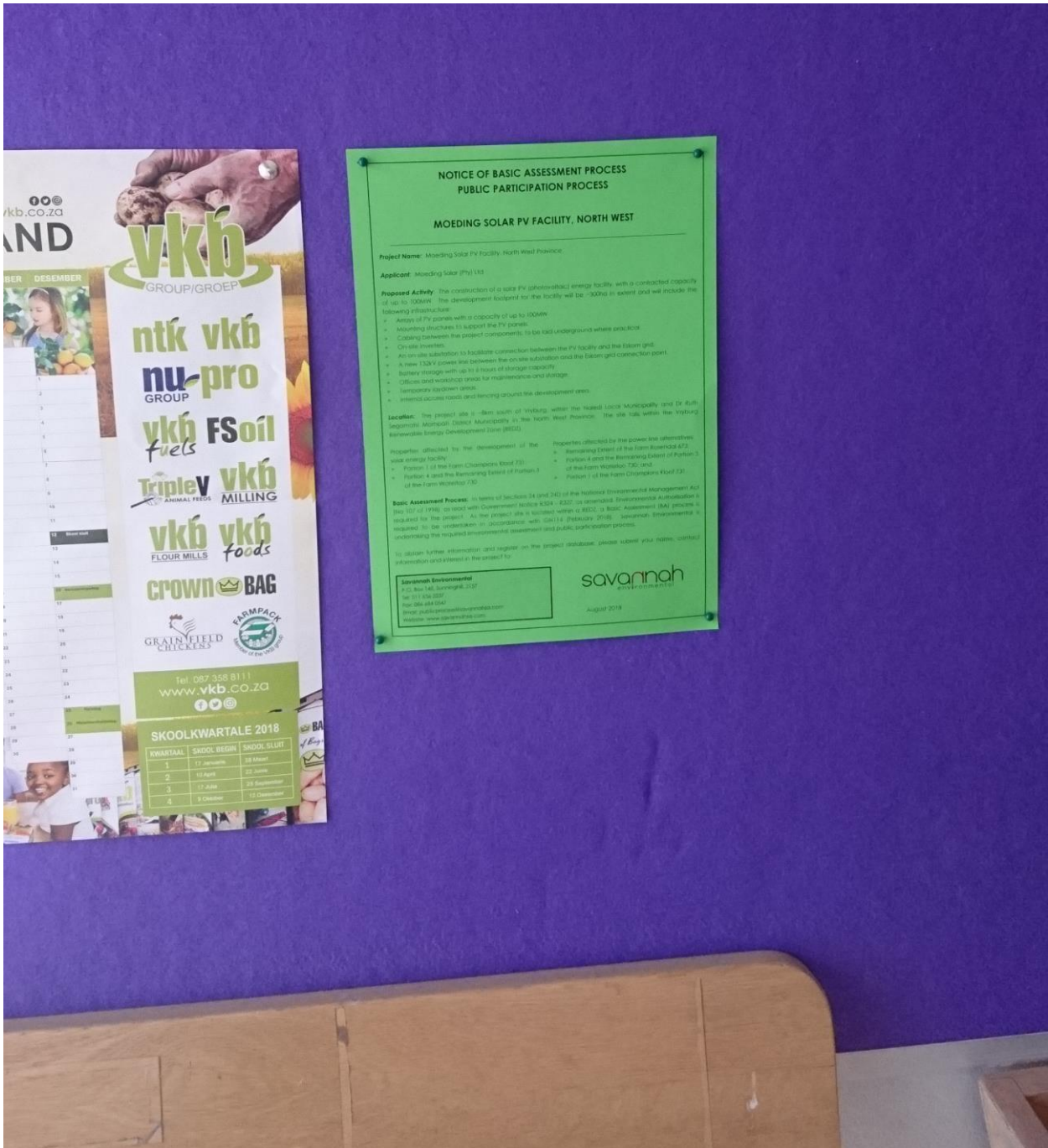


Figure 7: Notice placed at the Vryburg Public Library (26°57'22.92"S; 24°43'33.27"E)
