





Your email below refers.

I have checked the "discrepancies" you are referring to and am not sure what the issues are.

With regards to the end points of the South Connection options, they are supposed to end on the farm Uitzicht No. 3. The southern connection option for Option 1 ends on Remainder of the Farm Uitzicht No. 3, which is where the Coleskop WEF Substation is proposed. The southern connection option for Option 2 ends on Portion 8 of the Farm Uitzicht No. 3, which is where the Hydra D Main Transmission Substation (MTS) is proposed (power line connects to either Colsekop WEF sub or Hydra D MTS, depending on "preferred" grid connection alternative - see attached layout map).

It should be noted that Option 2a was chosen as the "preferred" grid connection infrastructure alternative (see attached layout map) and thus the power line ends on Portion 8 of the Farm Uitzicht No. 3 (Option 2a has a southern and northern connection, which both end on the farm Ultzicht No. 3). This farm was listed as one (1) of the farm portions affected by the power line corridor route associated with the 'preferred' grid connection infrastructure alternative (namely Grid Connection Option 2a). There should thus not be an issue with regards to this.

In addition, please can you explain what you mean by "Paarde Valley" not being listed in your database? I am not sure how I can assist in this regard? You are referring to the project and sending information from the DBAR, therefore, this project should be in your database. 
