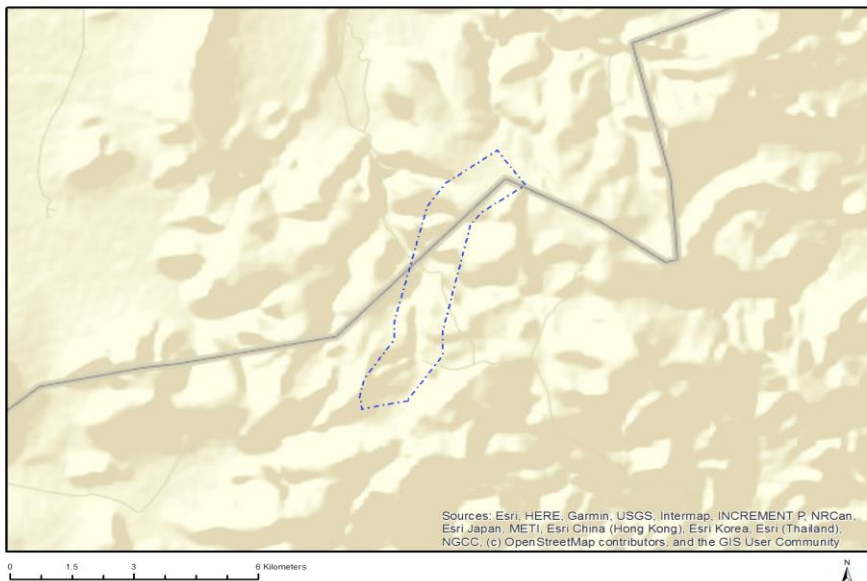

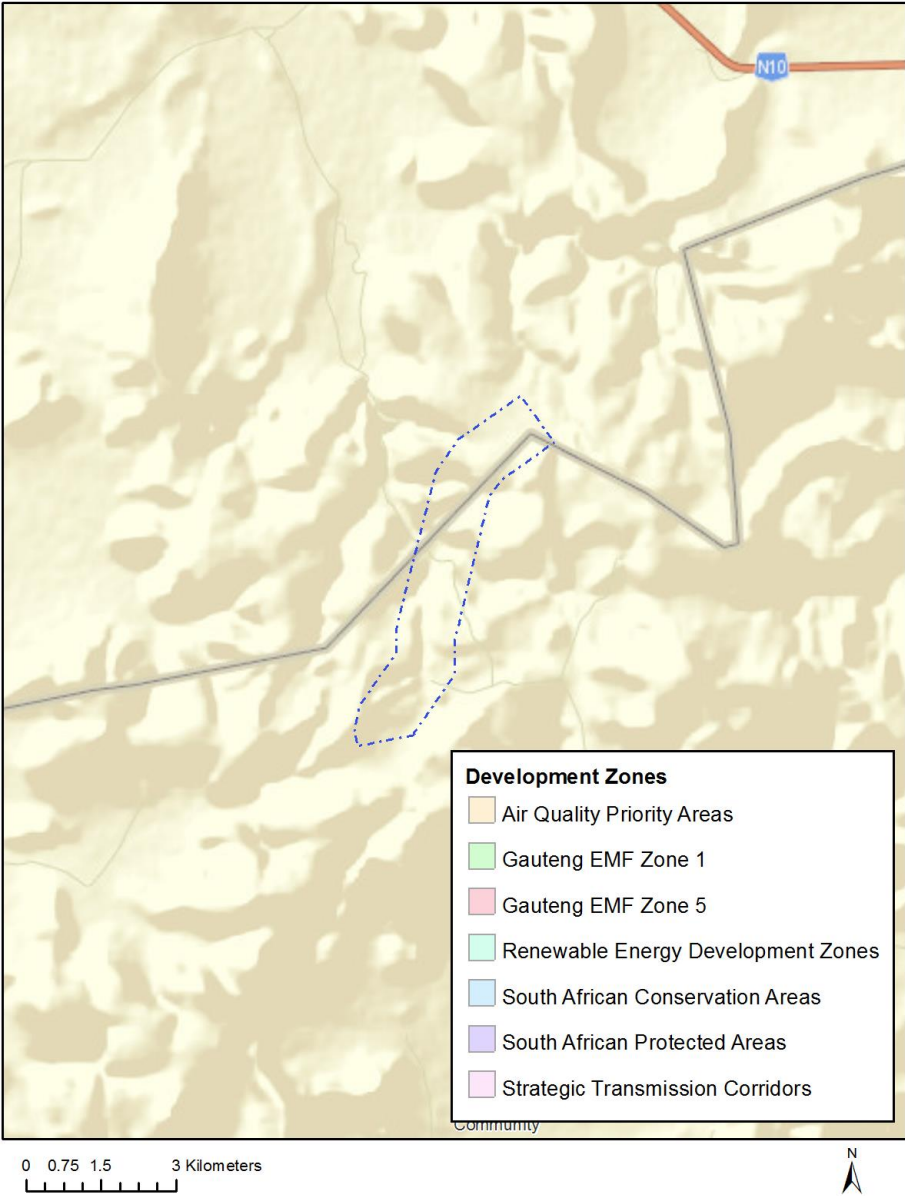

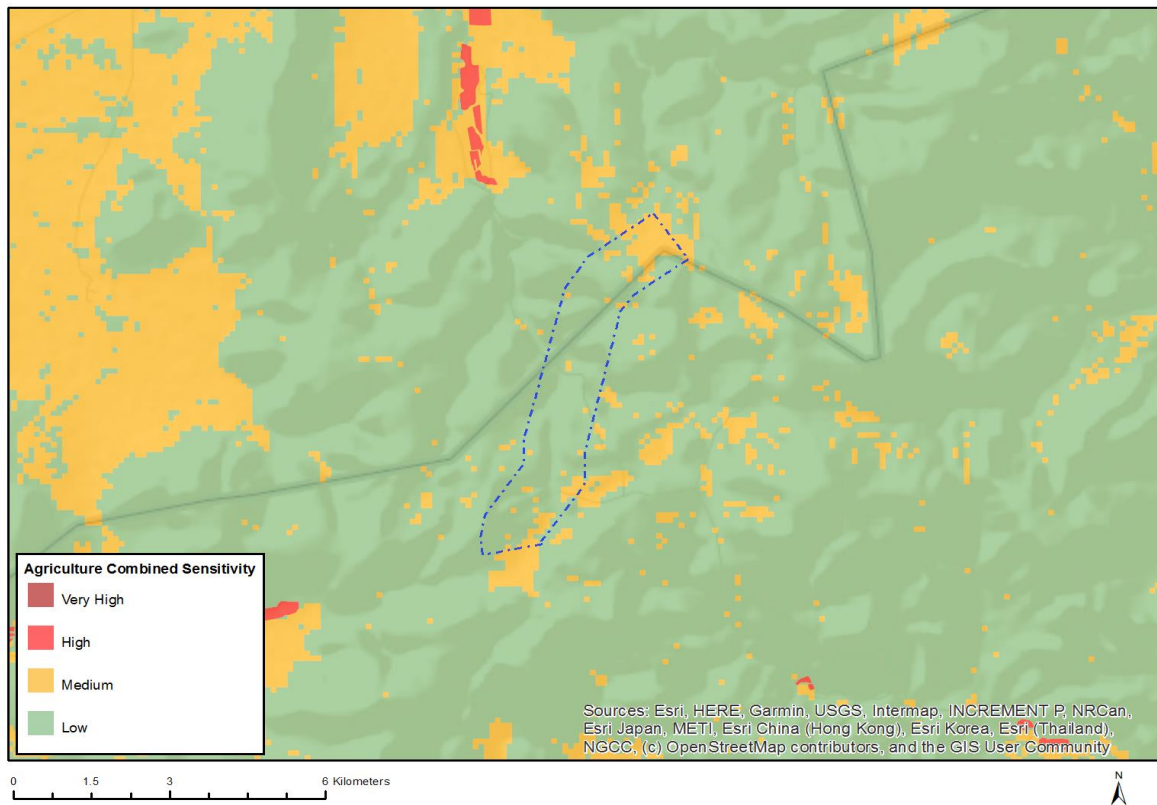

### MAP OF RELATIVE AGRICULTURE THEME SENSITIVITY

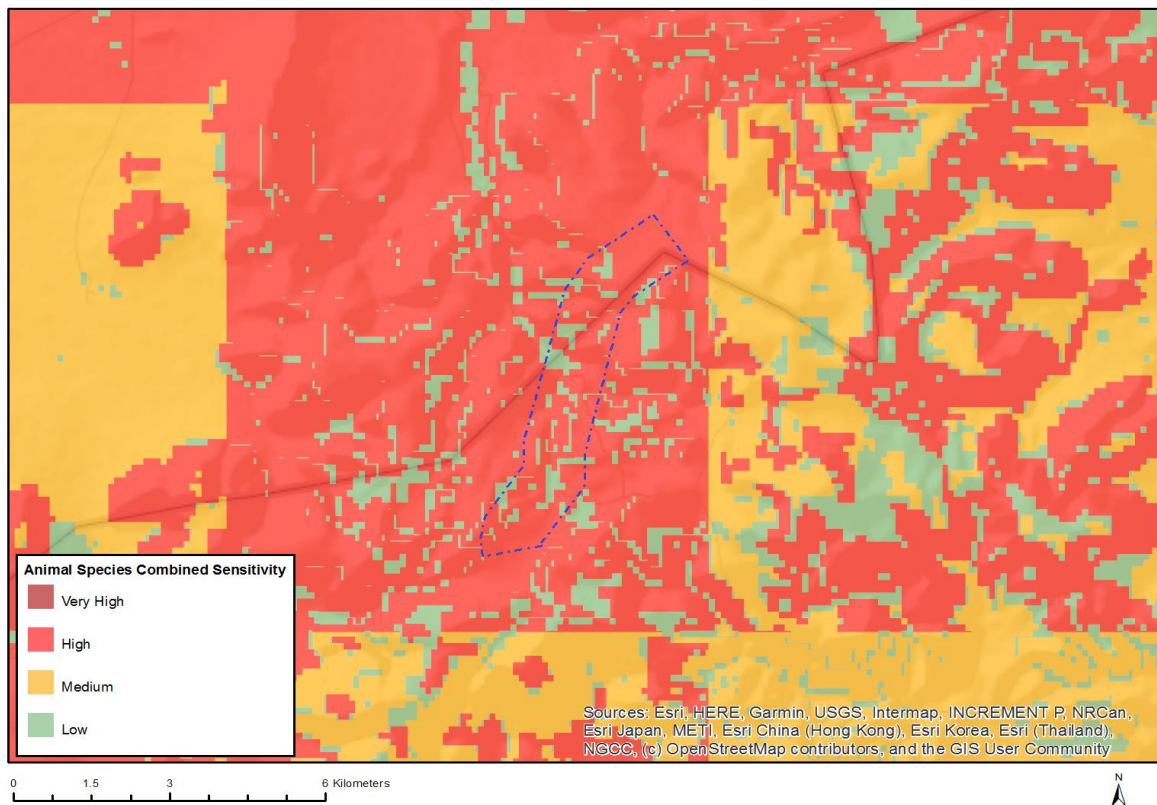

## MAP OF RELATIVE ANIMAL SPECIES THEME SENSITIVITY



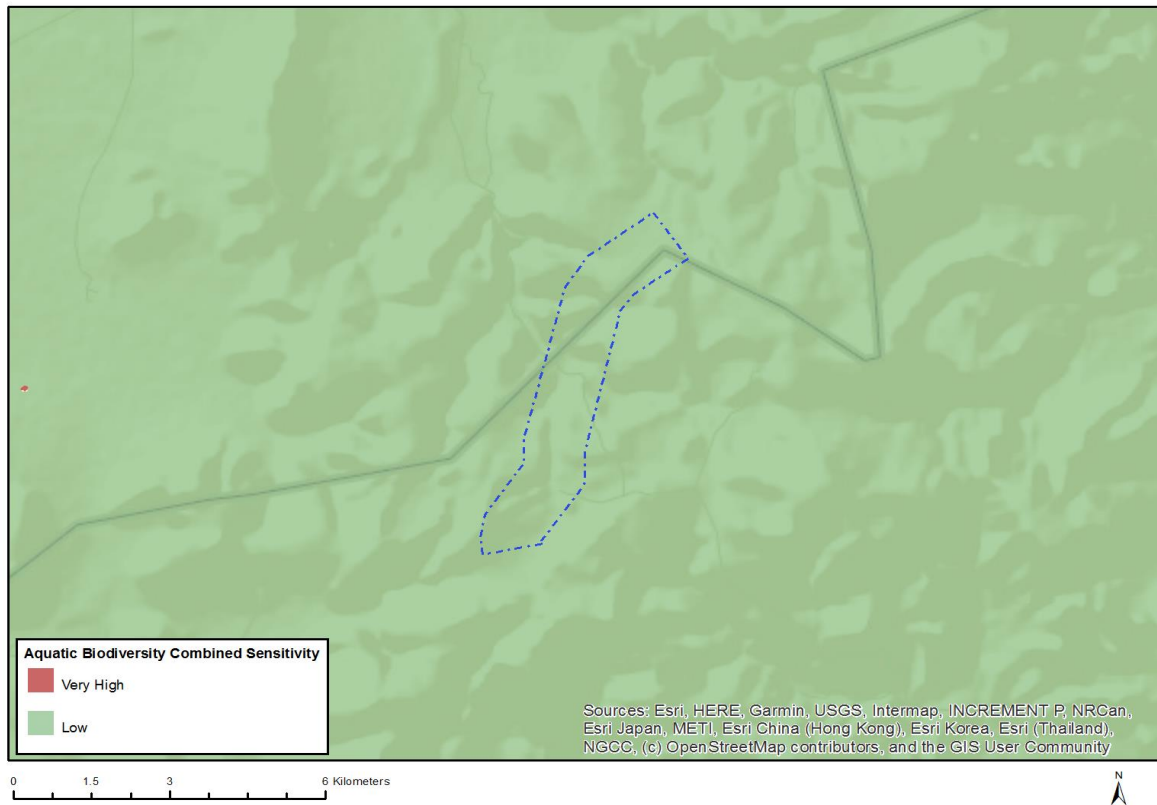

## MAP OF RELATIVE AQUATIC BIODIVERSITY THEME SENSITIVITY

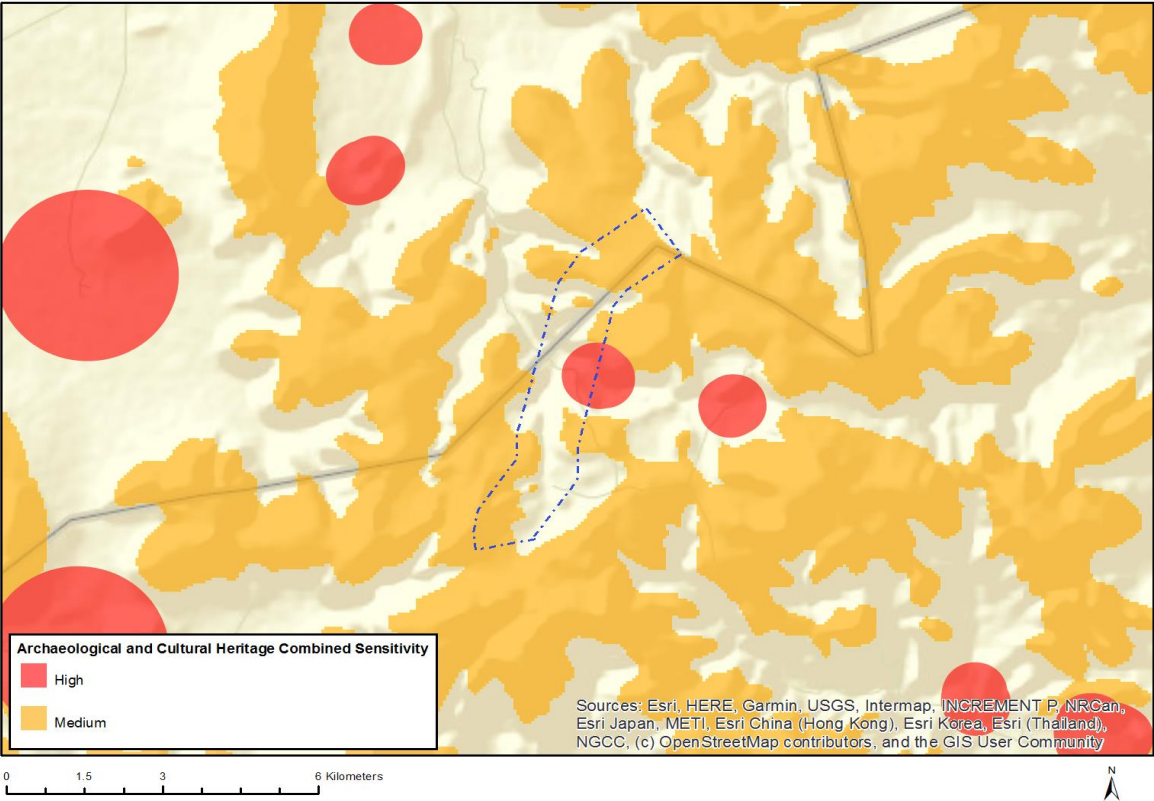

# MAP OF RELATIVE ARCHAEOLOGICAL AND CULTURAL HERITAGE THEME SENSITIVITY

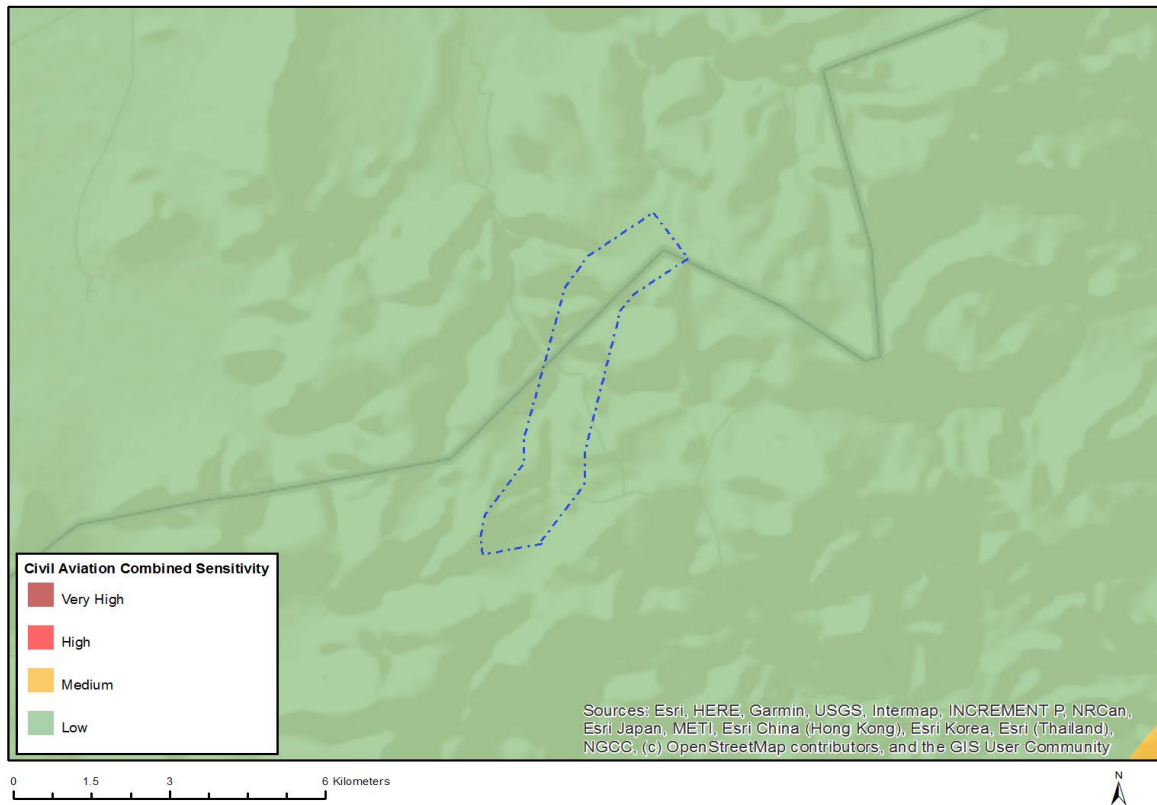

## MAP OF RELATIVE CIVIL AVIATION THEME SENSITIVITY



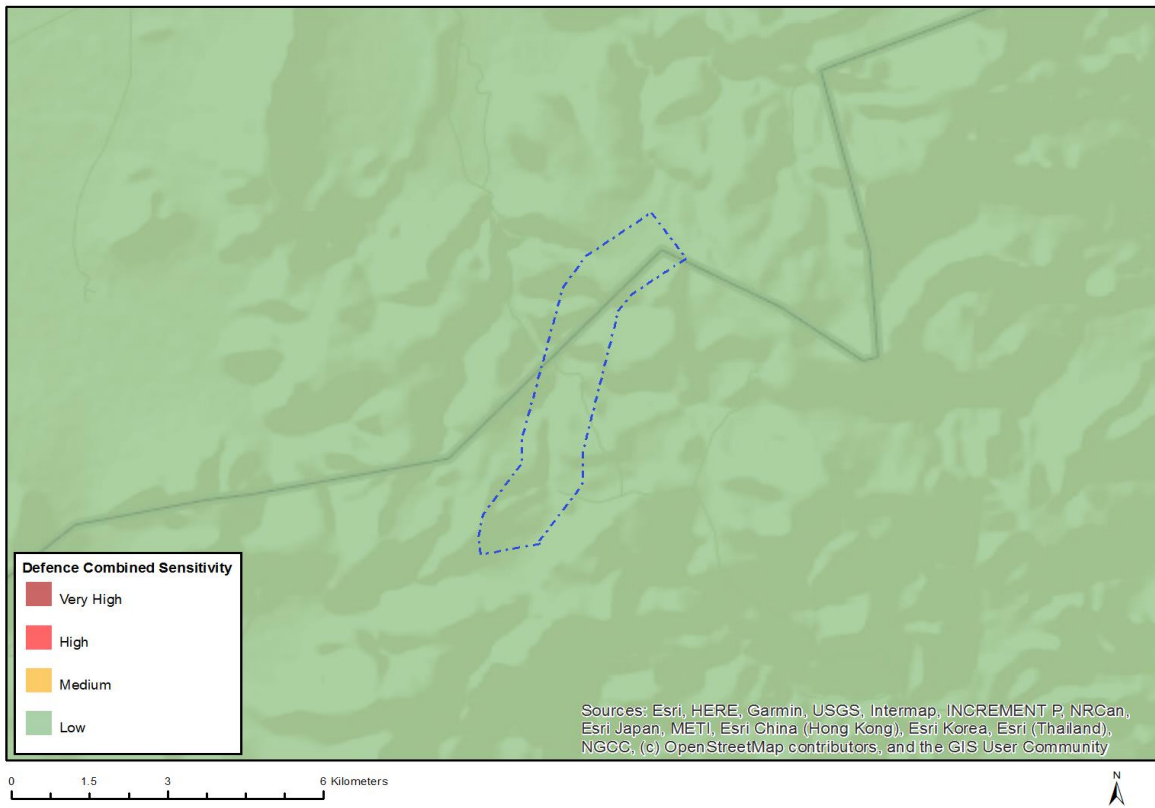

## MAP OF RELATIVE DEFENCE THEME SENSITIVITY

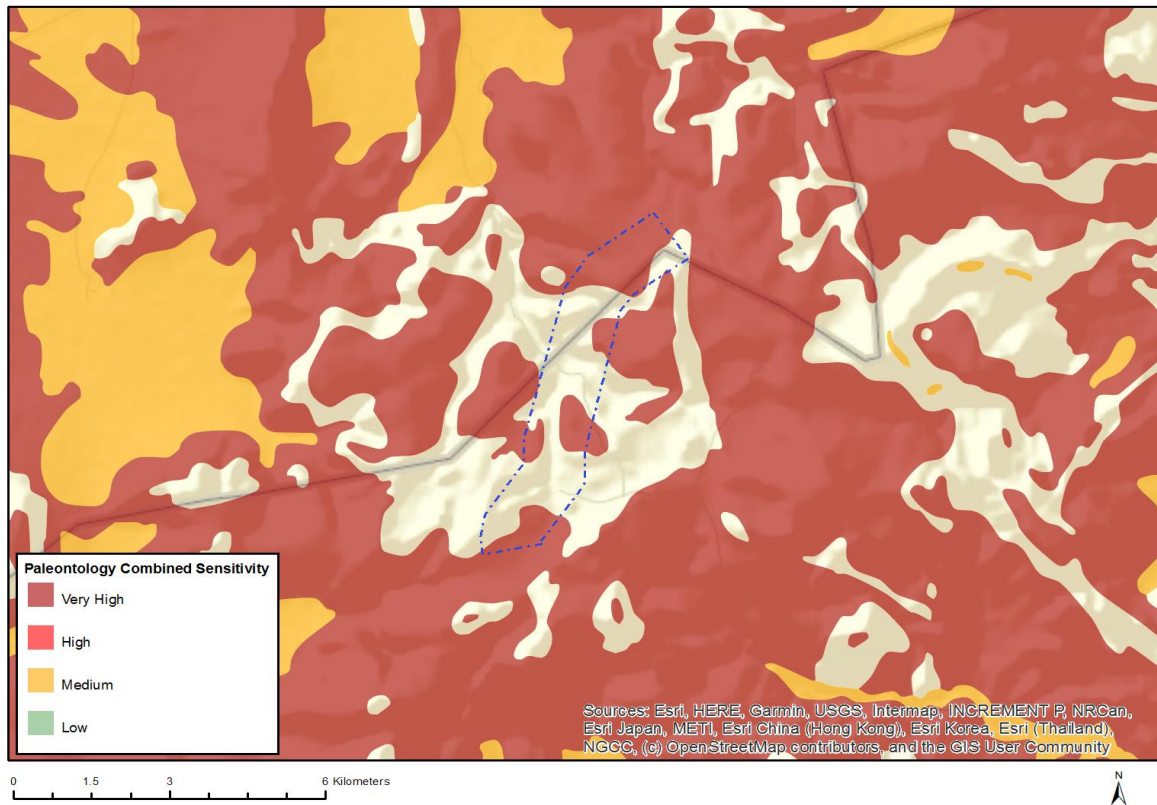

## MAP OF RELATIVE PALEONTOLOGY THEME SENSITIVITY



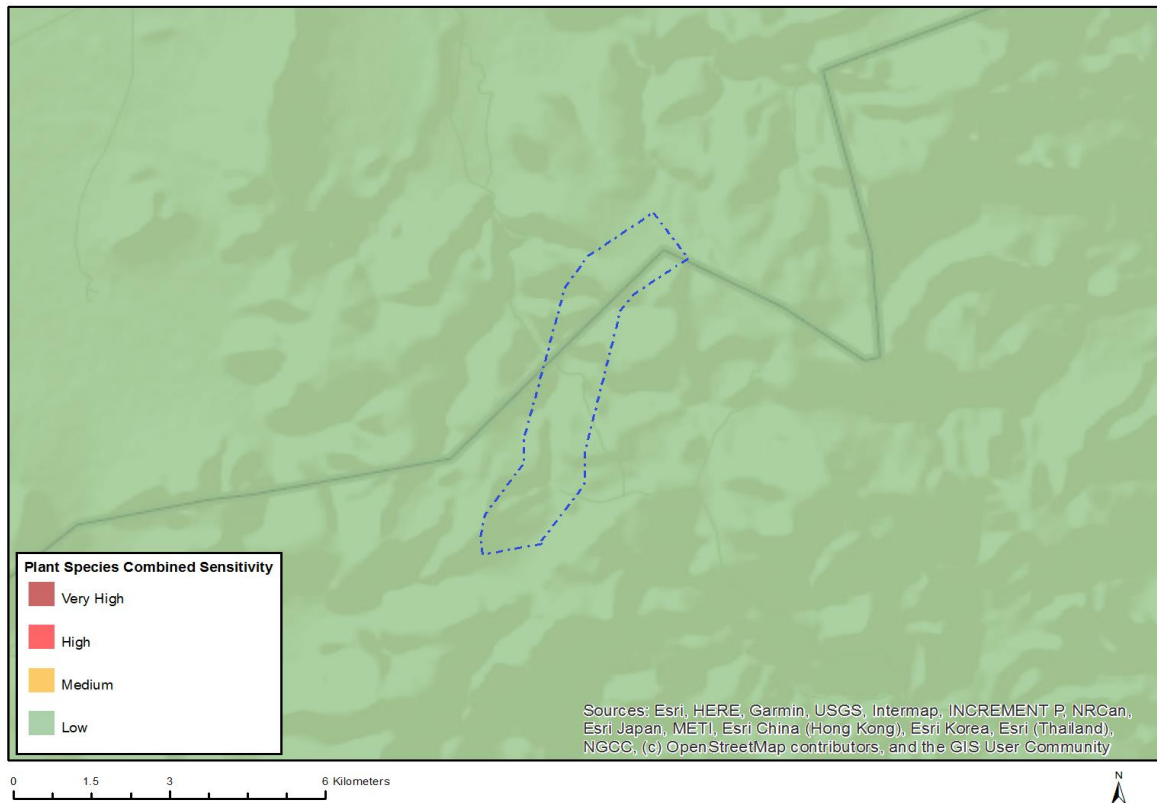

## MAP OF RELATIVE PLANT SPECIES THEME SENSITIVITY



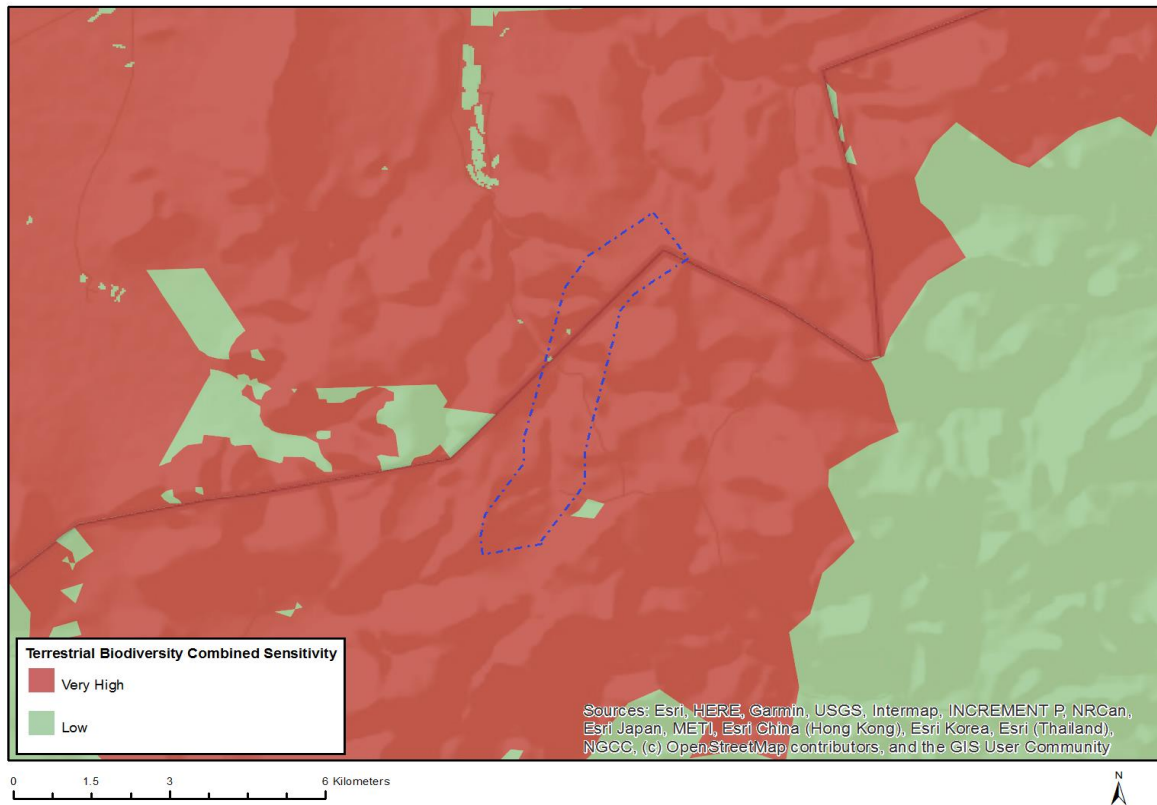
