The KwaZulu-Natal Film Commission (KZNFC) in partnership with the Mellon Foundation and the University of KwaZulu-Natal's Durban International Film Festival (DIFF) is inviting experienced scriptwriters to apply for the Mellon Foundation residency. This is a one-month residency taking place 28 June 2019- 28 July 2019 and will be based in Durban, KwaZulu-Natal. The residency is looking to develop short film scripts (15-20mins) and will run over the period of DIFF. The focus of the one-month residency is writing the scripts. The short films will be adaptations of Zulu Short Stories that are already in existence. Candidates who also wish to direct their films will then have to pitch to a panel to "direct" the film they wrote. Only competitive scripts will be considered for funding.
