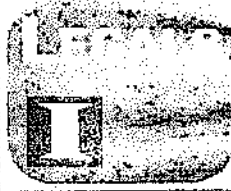

CONSTITUTION HILL: SAHRA NOTICE
The Johannesburg Development Agency, which is responsible for the building of the Constitutional Court and the development of Constitution Hill, situated in Johannesburg on the site bounded by Sam Hancock Street on the north, Albert Street Ext on the west, Kibler Street on the south and Hospital Street on the east, plans to demolish the buildings listed below which are situated on the western side of the site:

1. Stand RE/64 of Farm Braamfontein 531R. The kitchen block attached on its east side to Queen Victoria Hospital situated on the corner Sam Hancock and Joubert Ext, Johannesburg.
2. Stand RE/135 and 64 of Farm Braamfontein 531R. The lowest of three Queen Victoria Hospital apartment blocks attached to two taller wings on the north side.
3. Stand RE/135, 136, 183 and 184 of Farm Braamfontein 531R. Four houses and out buildings south of the Queen Victoria Hospital apartment blocks referred to (2) above.
4. Stand RE/69 of Farm Braamfontein 531R. The Johannesburg Mortuary buildings situated south of the houses referred to under (3) above.
5. Stand RE/69 of Farm Braamfontein 531R. The apartment building situated east of the Mortuary buildings referred to under (4) above.
6. Stand RE/69 of Farm Braamfontein 531R. The house and out buildings situated north of the apartment building referred to under (5) above.
