Dear Sir/Madam

I am a heritage officer in the Maritime and Underwater Cultural Heritage unit at SAHRA. I am currently reviewing old cases on SAHRIS as the previous manager of this unit, John Gribble, has now left SAHRA and some of his cases are still open. One of the cases is for the power barge at Ngqura Port, which was uploaded onto SAHRIS in 2016, SAHRA case ID 8716, CES are listed as the applicants with Belinda Hubby as the Consultant.

The interim comment that was issued by SAHRA regarding the DSR in connection to this case required that the final scoping report was amended to reflect that SAHRA rather than the PRHA was the competent heritage authority for work below the high water mark. The comment also requests that any specialist heritage reports include the review of any geophysical data by an underwater heritage specialist.

I am writing to enquire if the proposed development went ahead as no further final scoping reports or EIAs/HIAs were uploaded onto SAHRIS and, if so, whether the comments supplied by SAHRA were addressed? Could you please, if possible, update me on the project status as I am aiming to update and close any of Johns cases that have been completed.

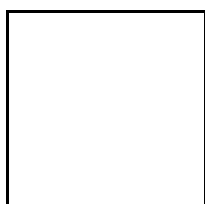
