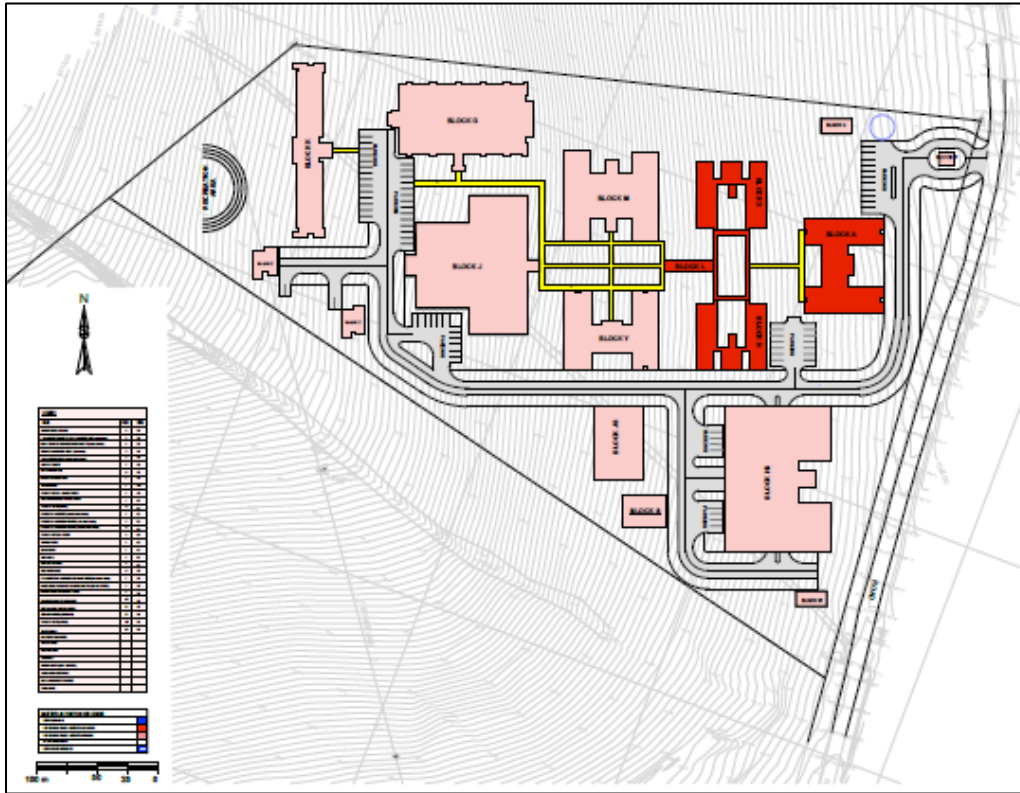


Figure 1: Map showing alternative layout A for the proposed Nkandla B FET College




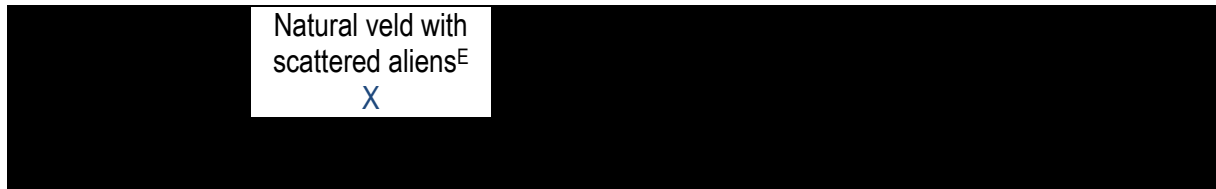

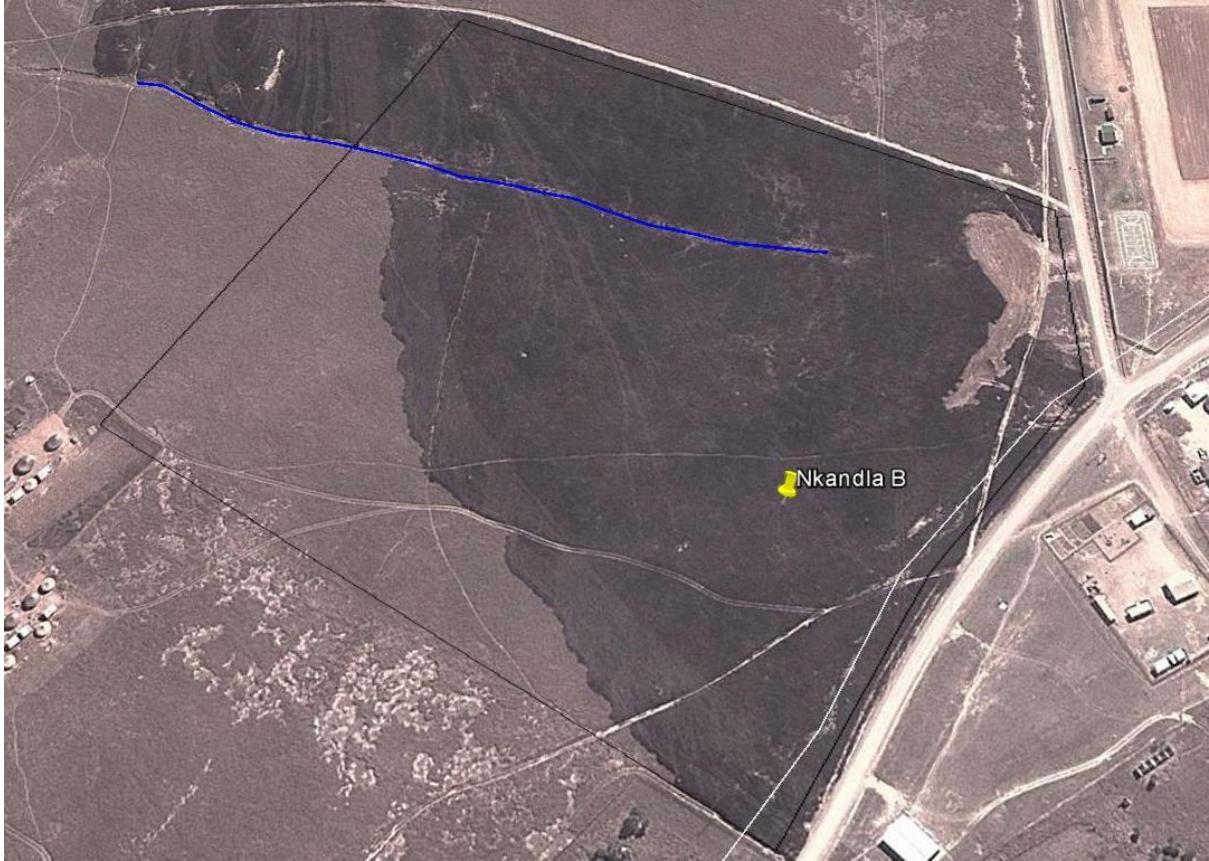


Figure 4: Map showing the wetland and river adjacent to the proposed site

According to the wetland delineation undertaken by SDP (2013), no wetland was noted on site, however a weakly defined intermittent surface runoff fed drainage line was identified (Figure 4). The site has a gently sloping topography with a shallow valley draining the central portion of the site. This forms a natural low point to which surface runoff would flow, gather and move off site. Evidence of surface flow was noted, which included slight erosion and polishing of the clayey soils between isolated tufts of *A. junciformis*. No hydromorphic soil conditions were noted. All evidence indicated intermittent surface flow only with little or no penetration into the firm clayey soils.

The site falls within the Savanna Biome and is characterised by the Northern Zululand Sourveld. The Northern Zululand Sourveld vegetation type is found in the KwaZulu-Natal Province and Swaziland: From the Lusthof area in Swaziland southwards with scattered patches in northern Zululand in the surrounds of Hlomohlomo, east of Louwsburg, Nongoma and the vicinity of Ulundi including Nkandla. In the Hluhluwe-iMfolozi Park it occurs at highest altitudes in the park (Mucina and Rutherford, 2006).

The Important taxa in this vegetation type includes species such as *Acacia sieberiana*, *Acacia natalitia*, *Acacia nilotica*, *Acacia tortilis*, *Pleactroniella armata*, *Gardenia volkensii*, *Gnidia caffra*, *Gnidia kraussiana*, *Agathisanthemum bojeri*, *Chaetacanthus burchelli*, *Crossandra fruticulosa*, etc. (Mucina and Rutherford, 2006).

The conservation status of this vegetation type is classified as Vulnerable with a national conservation target of 19%. Only about 4% is statutorily conserved, mainly in the Hluhluwe-iMfolozi Park and Ithala Game Reserve. Some 22% already transformed, mainly by cultivation and plantations (Mucina and Rutherford, 2006).

According to the biodiversity study undertaken by SDP (2013), one species was recorded in and adjacent to the drainage line, *Aristida junciformis*. Although an indicator of temporarily wet conditions (DWAF 2005), the dominance of *A. junciformis* within the site area was not related to wetland conditions, but rather a degraded grassland. The site is an example of poor veld management. Over grazing and excessive burning have more than likely resulted in the *A. junciformis* monodominance. Floral diversity of the site is low. The probability of any RDB plant species occurring within the site boundary is almost nil. None were noted during the site visit and given the dominance by *A. junciformis* and the prolonged disturbance that lead to the alteration of the veld, it is unlikely that any survived.
