

NOTIFICATION AND BACKGROUND INFORMATION DOCUMENT (BID)

Integrated Water Use Licence Application for an irrigation dam on Portion 2 of Farm Waterfall 996 JT, 20km northwest of Barberton, Ehlanzeni District Municipality, Mpumalanga Province.

PURPOSE OF THIS DOCUMENT

The purpose of this document is to provide notification of and background information to the proposed project and to obtain comments, contributions & appeals from stakeholders with regards to potential water resource impacts – which includes (but is not limited to): ecological, social, economic, physical, aesthetic, etc.

When an applicant proposes to undertake a Section 21 water use, an application must be made for a license, where other forms of water use authorization are not applicable. The application must be supported by a report, which has been compiled as a result of an assessment process.

Ecoleges, as an independent Environmental Consultant, has been appointed to manage the Public Participation Process (PPP) as part of the Integrated Water Use License Application (IWULA) which will be undertaken in accordance with Regulations 17 to 19 of the Water Use License Regulations (GN No. R.267, 24 March 2017) and section 41(4) of the National Water Act (Act 36 of 1998), taking into consideration the Public Participation 2017 Guideline Document (DEA, 2017). The IWULA will be submitted to and reviewed by the relevant competent authority, namely the Inkomati-Usuthu Catchment Management Agency (IUCMA), as the appointed agents on behalf of the provincial Department of Water & Sanitation (DWS).

YOUR COMMENTS WILL FORM PART OF THE IWUL APPLICATION REPORT

APPLICABLE LEGISLATION

An Integrated Water Use License Application (**IWULA**) under the provisions of the National Water (Act No. 36 of 1998 (NWA)) is required for several water uses on the property including:

- Section 21 (b): storing of water (storing of water in an earthen dam);
- Section 21 (c) Impeding or diverting the flow of water in a watercourse (the dam impedes flow in an ephemeral tributary of the Noordkaap River); and
- Section 21 (i) altering the bed, banks, course or characteristics of a watercourse (the bed & banks of the tributary are affected by the dam wall).

Section 21(a): taking of water for irrigation from the Noordkaap River, has already been declared an Existing Lawful Use by the IUCMA, and will not form part of this application.

PROJECT DESCRIPTION & PURPOSE

ECOLEGES were appointed by Greyvan Investments (Pty) Ltd, to undertake an Intergrated Water Use License Application (IWULA) for an existing (since 2010) irrigation dam on Portion 2 of the Farm Waterfall 996 JT, Ehlanzeni District Municipality, Mpumalanga Province.

The overall objective is to undertake and complete a robust and defendable IWULA process that will serve to inform the IUCMA's (DWS) decision on issuance of the requisite license.

DESCRIPTION OF TASKS

Regulations 17 to 19 outline the full details of the tasks that must be undertaken in fulfillment of a complete Public Participation Process, which includes:

- An advertisement was placed today in the Laevelder Newspaper;
- Stakeholders, including the owners of the adjacent properties, and the relevant authorities will be notified of the proposed development in writing;
- Notice boards advertising the applications will be placed at the site.

LOCATION




Figure 1. The yellow pin in the top-center, indicates the location of the Waterfall Dam on Portion 2 of Farm Waterfall 996 JT, between Nelspruit and Barberton, west of the R40.

ANTICIPATED ISSUES

Preliminary issues that may be addressed in the Report could include the following:

- Aquatic studies including Present Ecological Status;
- Wetland Delineation (including 1:100-year flood line & Riparian zone determinations);
- Surface water hydrology;

Your comments on the proposed projects, the public participation process, and issues needing investigation, will assist the technical studies and the authorities in their consideration of the relevant environmental and social aspects.

You are invited to register as an Interested and Affected Party (I&AP) and to assist us in:

- identifying possible impacts of the proposed developments on the environment & water resource,
- making suggestions for mitigation and / or alternatives, and
- considering the "need" and "desirability".

Mitigations

Mitigation measures will be developed for the anticipated issues. Stakeholders are however welcome to comment on these issues and provide additional observations.

Alternatives

Consideration of "Alternatives" is one element of the IWULA process. Its role is to provide a framework for sound decision-making based on the principle of sustainable development. Alternatives should be identified as early as possible in the project cycle. Ecoleges not only welcomes stakeholders' inputs / suggestions, but also urges the public to submit possible alternatives.

It is important to note that an alternative is defined as a different means of meeting the general purpose and requirements of the activity, which may include alternatives to-

- (a) the property on which or location where it is proposed to undertake the activity;
- (b) the type of activity to be undertaken;
- (c) the design or layout of the activity;
- (d) the technology to be used in the activity;
- (e) the operational aspects of the activity; and
- (f) the option of not implementing the activity.

When submitting alternatives, the recommended alternative must be:

- Practicable,
- Feasible,
- Relevant,

• Reasonable and

• Viable.

Need and Desirability

'Need and desirability' is determined by considering the broader societal / community needs and interests. The general meaning of need and desirability refers to time and place, respectively, i.e. is this the right time and is it the right place for locating the proposed activity.
