This Background Information Document (BID) serves to inform you, as a potential Interested and Affected Party (I&AP), of the proposed application for Environmental Authorisation for the following project: Expansion of the Excelsior Abattoir - Kuruman. The Environmental Authorisation application will be lodged in due course with the Northern Cape Department of Agriculture, Environmental Affairs, Rural Development and Land Reform (the Competent Authority) in terms of the National Environmental Management Act (NEMA), 1998 (Act No. 107 of 1998), as amended, and the Environmental Impact Assessment (EIA) Regulations, 2014 (Regulations in terms of sections 24(5) and 44 of the NEMA, 1998), as amended. For this Environmental Authorisation application, a Basic Environmental Impact Assessment will be conducted.

The applicant, Excelsior Abattoir CC, has appointed EARTHnSKY Environmental (Pty) Ltd. in terms of Regulation 12 of the Environmental Impact Assessment Regulations, 2014, as amended, as the independent Environmental Assessment Practitioner (EAP) for the above-mentioned application process. EARTHnSKY Environmental complies with the requirements of Regulation 13 of the Environmental Impact Assessment Regulations 2014, as amended.

### **PROJECT DESCRIPTION**

Expansion of the Excelsior Abattoir to increase the cattle (red meat) slaughtering capacity from 50 to 200 cattle per day. The expansion will include internal changes to the abattoir as well as the expansion of the abattoir building to accommodate an additional cold storage room with three product loading bays. The main abattoir building will be extended to the north-west and the offices will be extended to the north-east.

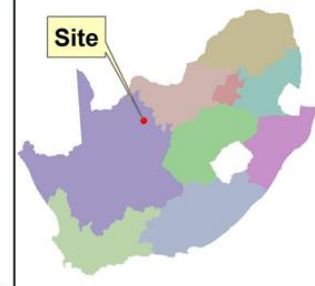
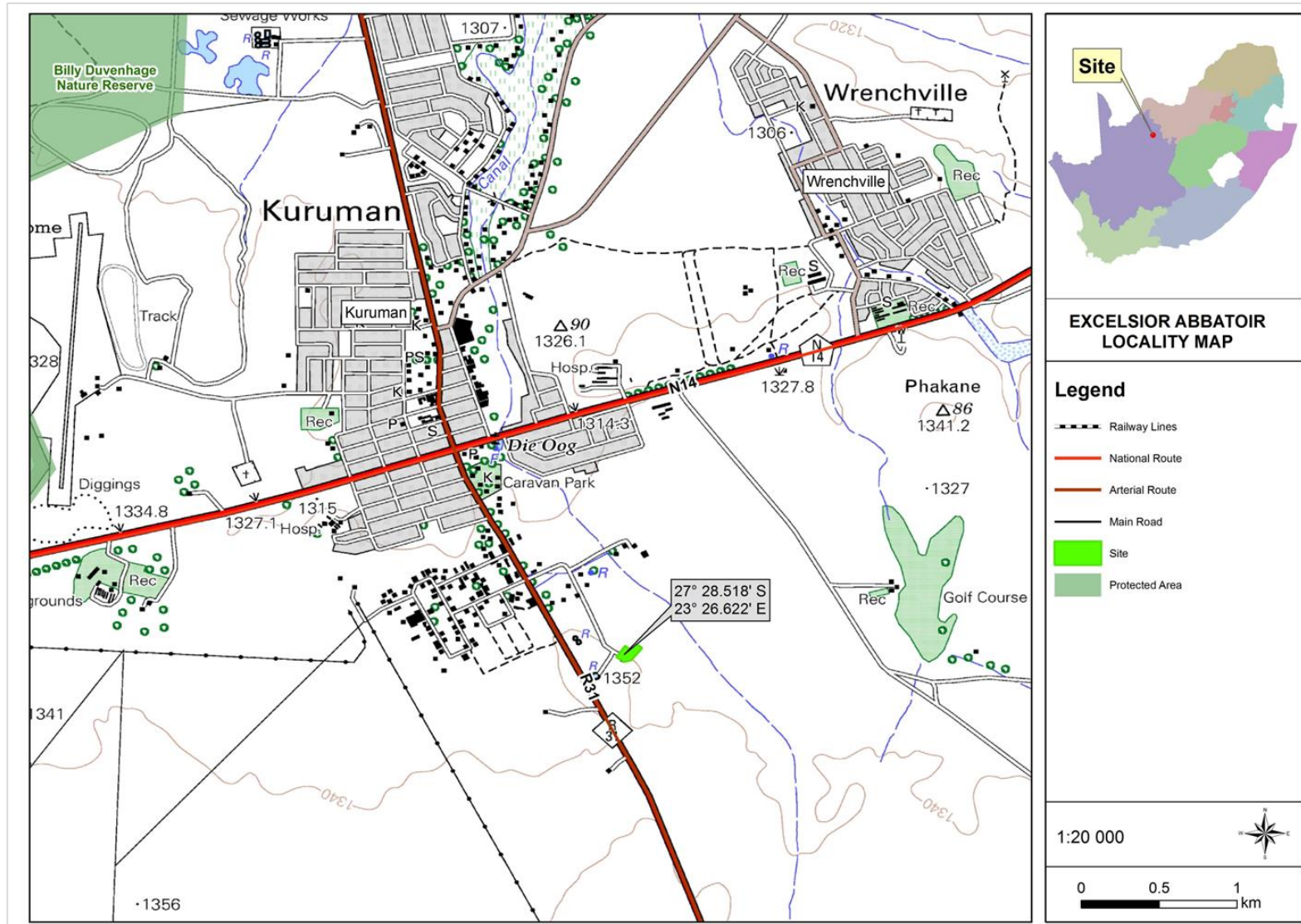

## LEGISLATION APPLICABLE TO THE PROJECT

The proposed project requires Environmental Authorisation and a Basic Environmental Impact Assessment process for the following listed activity in terms of the Environmental Impact Assessment Regulations, 2014, as amended:

- GNR. 983 of 4 December 2014 (Listing Notice 1), as amended: Activity No. 38: The expansion and related operation of facilities for the slaughter of animals where the daily product throughput will be increased by more than –  
(ii) 6 units of reptiles, red meat and game.

The Environmental Authorisation application will be submitted to the Competent Authority in due course. Upon acceptance of the application, the Competent Authority will issue a reference number for the application. The reference number will be communicated to I&APs once received.

The following reports are applicable to this application for Environmental Authorisation:

- A Basic Assessment Report in accordance with Appendix 1 of the EIA Regulations, 2014, as amended; and
- An Environmental Management Programme in accordance with Appendix 4 of the EIA Regulations, 2014, as amended.

A hard copy of the report will be available for review from 21 June 2023 at the Kuruman Library. Electronic copies of the report will be provided to registered I&APs via email or WhatsApp. Please inform us should you require a hard copy of the report instead.

## Protection of Personal Information Act, 2013 (Act No. 14 of 2013) (POPIA)
