NOTICE OF A VARIATION APPLICATION OF THE PROVISIONAL ATMOSPHERIC EMISSION LICENCE BY CAPE DAIRY BIOGAS (PTY) LTD LICENCE NUMBER WC/WC/028

Background information

The West Coast District Municipality issued Cape Dairy Biogas (Pty) Ltd. ("CDB") a Provisional Atmospheric Emissions Licence ("PAEL") (WC/WC/028) dated 04/08/2015 for the operation of a biogas digester near Malmesbury in the Western Cape. CDB have requested a variation to this PAEL, increasing the size of the facility from 5 MW to 9.8 MW.

Legislative Requirements

In terms of Section 22 of the National Environmental Management: Air Quality Act 39 of 2004 (NEM: AQA) no person may conduct an activity listed on a national list anywhere in the Republic of South Africa or listed on a list applicable to a province anywhere in that province without a PAEL or an Atmospheric Emission License ("AEL").

The following listed activities, as published in terms of section 21 of the National Environmental Management: Air Quality Act, 2004 (Act No. 39 of 2004), are proposed to be conducted at the premises in terms of this application:
