APPEAL PROCEDURE

Further to this decision, an appeal process must be implemented to provide all registered I&AP's the chance to appeal against the decision in terms of the appeal procedure provided for in Chapter 2 of the National Appeal Regulations published in Government Gazette No. 38559 of 12 March 2015 (as amended) (see attached Appendix 2). The following steps are required of an appellant and are described below.

Appeal Procedure:

Should any I&AP's wish to appeal any aspect of the decision an appellant must, within 20 (twenty) calendar days from the date of notification (before or on 09 January 2022; excluding 15 December 2022 – 05 January 2023):

1. Submit an appeal with the Appeal Administrator for DEDECT within 20 calendar days after being notified of the decision;
