**NOTIFICATION OF ENVIRONMENTAL AUTHORISATION: PROPOSED HUMPHRIES BOERDERY WEAN-TO-FINISH SITE PROJECT ON PORTION 50 OF THE FARM TWEEFONTEIN 463 KR**

You are hereby notified that the Limpopo Department of Economic Development, Environment and Tourism (LEDET) has decided to grant Environmental Authorisation for the above mentioned project in terms of the powers vested in it by the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended, and the Environmental Impact Assessment Regulations, 2014. The decision to grant the Environmental Authorisation was signed on the 31<sup>st</sup> of March 2017 and issued to the client on the 3<sup>rd</sup> of April 2017. In terms of regulation 4(2) of the Environmental Impact Assessment Regulations, 2014, all registered interested and affected parties must be notified within 14 calendar days of the Department's decision in respect of this Environmental Authorisation as well as the provisions regarding the making of appeals that are provided for in the regulations.

In accordance with Chapter 2 of the National Appeal Regulations (Government Notice No. R993 of 8 December 2014), should you wish to appeal any aspect of the decision of granting the Environmental Authorisation, you must submit the appeal to the MEC of the Limpopo Department of Economic Development, Environment and Tourism within 20 days from the date of the notification of the decision of the application for environmental authorisation was sent to the registered interested and affected parties. In other words, within 20 days from the date of this letter, by means of the following methods:

- By hand: Environmental Affairs Offices, Corner of Suid and Dorp Streets, Polokwane, 0699.

The expiry date for the submission of appeals to the LEDET is therefore **8 May 2017**.

A copy of the appeal must be submitted to the applicant, any registered interested and affected party and any organ of state with interest in the matter as well as a notice indicating where and for what period the appeal submission will be available for inspection.
