**10MW HARMONY NYALA SOLAR ENERGY FACILITY AND ITS ASSOCIATED INFRASTRUCTURE WITHIN THE

**REQUEST TO UPDATE PROPERTY DESCRIPTION IN FINAL COMMENT FOR NYALA PV**

Dear Ragna,

Savannah Environmental (Pty) Ltd was appointed by Nyala Photovoltaic (Pty) Ltd to provide support and assistance in meeting the permitting requirements for financial close, which included, amongst other tasks, revising the Environmental Management Programme (EMPr) to include the conditions of the Environmental Authorisation (EA) and findings of the heritage walkdown of the final development footprint (i.e., the solar PV area, power line, access route and substation). Following compilation of the revised EMPr and heritage walkdown report, the case for this project was resubmitted for final comment, which was subsequently issued on 29 June 2021.

Following receipt of the final comment, it was noted that the property description in the final comment does not reflect the correct property names and as a result, a request to update the property description to include the Farm Fregul 443 in the final comment was sent to you on 02 July 2021, following which you indicated that formal documentation indicating that Fregul 443 was assessed as part of the Basic Assessment (BA) process is required before this request can be processed.

As requested, please find attached the final Basic Assessment Report (see **Appendix A**) indicating that Fregul 443 was assessed as part of the BA process undertaken in 2015. Kindly note that the property was not included in the EA cover letter issued for this project as the power line that traverses the property does not trigger a listed activity. In addition, Fregul 443 was previously known as Rheederpark 443 as is reflected in the final BA Report dated 2015.

I have also attached the original EA dated 23 March 2016 (DFFE Reference:14/12/16/3/3/1/1472) (see **Appendix B**) in support of this request. Page 5 of the EA includes F0240000000044300000, i.e., the SG code for Fregul 443 (previously Rheederpark 443) as one of the SG codes.

Given the above, we would like to request that the final comment letter be updated to include this property (i.e., Fregul 443) in the first and second paragraph speaking to the description of the project.
