INTRODUCTION

Umlando originally surveyed the proposed Nyala Farm broilers on 18 May 2022. The survey noted several isolated Early Stone Age artefacts along the upper part of the hill. There was a stone cairn on the western border of the footprint. This feature was described in the HIA report: "A stone cairn, that resembles a grave, was noted in the southern part of the study area. While it is unlikely to be a human grave, it currently falls within the definition of a human grave and needs to be treated as such. This cairn will need to be buffered."

KZNARI undertook a site inspection and agreed that the cairn should be buffered.

The landowner later confirmed that it was part of an excavation with a TLB, and not a grave. I suggested that this is tested by removing some of the rocks on the cairn to determine if it is a grave. This was to be *pro bono*. KZNARI rejected this and requested GPR analysis. This would be an extra and unnecessary cost to the project.

I then contacted the landowner stating that if they cleared the vegetation, without disturbing the cairn, then a second assessment may provide more information. The grass was very long and dense in May and it restricted visibility.

The vegetation was cut on the day I revisited the study area and I reassessed the site and cairn. The cairn is clearly the result of a small excavated trench. The material from the trench was placed in one pile that subsided into a \sim 1.2m x 2m pile of rocks with sand in the middle. The profile of both sides of the trench are clear indications that there is no grave and that the cairn is only a pile of rocks placed on top of the surface. The photos below indicate that the cairn is what I originally stated: "A stone cairn that resembles a grave but is probably not a grave." I can now state that it is definitely not a grave.
