UNDERTAKING TO SAHRA RELATED TO THE APPLICATION FOR OE4 PROSPECTING RIGHT OVER VARIOUS PORTIONS OF THE FARM EYERDOP PAN NO 58, PRIESKA DISTRICT, NORTHERN CAPE PROVINCE ORION EXPLORATION NO. 4 (PTY) LTD [OE4]

Orion Exploration No. 4 (Pty) Ltd (OE4) has submitted linked prospecting right and environmental authorisation applications over the above-mentioned area. The BAR+EMPr (Basic Assessment Report and Environmental Management Programme) was submitted On 9 April 2021 and is currently under evaluation by the authorities.

The following is a summary of the Prospecting Right application and relating consultation with SAHRA:

- 1. A letter was sent to SAHRA on the 6th of January 2021 as notification of the Prospecting Right application.
- 2. SAHRA provided an Interim Comment, dated 29 January 2021, requesting that an assessment of archaeological resources and a desktop Palaeontological Impact Assessment (PIA) be conducted and that a copy of the draft Basic Assessment Report (BAR) be submitted for perusal.
- 3. Subsequent the receipt of the Interim Comment from SAHRA, the three surface owners of the properties under application were contacted to arrange access to the farms for the specialist.
- a. Mr. F. van der Westhuizen, one of the surface owners, denied access to his properties.
- b. No written response (to date) has been received from either the Boegoe Trust or Mr. Hudson, the other two surface owners; however it was indicated during a meeting held that access will be denied to OE4 (or anyone appointed by OE4).
- 4. The draft BAR was submitted to SAHRA on the 12th of March 2021. This document contained the comprehensive desktop HIA and PIA reports as well as a detailed description of the reason for conducting only a desktop HIA and not a field-based HIA.
- 5. SAHRA provided a second Interim Comment, dated 31 March 2021. SAHRA's position is still that a field-based HIA be completed as part of the EA process.

OE4 wishes to adhere to all legislative requirements and timeframes to obtain the Prospecting Right applied for; however due to the abovementioned constraints are unable to obtain the relevant specialist studies as requested by SAHRA.

OE4 hereby provides an Undertaking that a field-based HIA (Heritage Impact Assessment) shall be conducted before any invasive prospecting commences on any proposed area within the prospecting right area.
