INTRODUCTION

The Big 5 Hlabisa Local Municipality intends to construct a Culvert Causeway and Gravel Road in Osakweni (Ward 11). The area is situated on the South-western part of Umkhanyakude District. The proposed development will improve road and stream crossing conditions.

Emvelo Consultant is appointed as an Environmental Assessment Practitioner (EAP) by Big 5 Hlabisa Local Municipality, to assess the possible impacts to the environment that might emerge as a result of the proposed construction of the Gravel Road and a Culvert causeway. This will allow the identification of all the negative impacts at an early stage of the project, the mitigation measures to be implemented to reduce the impacts and to ensure that the proposed project is shaped to suit the local environment.

NEEDS AND DESIRABILITY

The community of Osakweni currently relies on the poor road conditions to access different part of the village .In the event of heavy or intense rainfall, it becomes a challenge for road users to gain access to the adjacent part of the village. Therefore the construction of a culvert causeway and gravel road will enhance connectivity and improve access regardless of any weather conditions.

WHAT DOES THIS DOCUMENT TELL YOU?

This document aims to provide you, as an Interested or Affected Party (I&AP), with information regarding the Basic Assessment Report and a Water Use Licence Application for the proposed development of a Gravel road and Culvert Causeway. It aims to obtain comments and contributions from I&AP's with regard to potential impacts on the environment.

Any person, company, authority or other entity that might be directly or indirectly affected by the proposed activity is invited to register as an I&AP, in order to assist the EAP in identifying possible impacts and to make suggestions for mitigation. These comments will be included as part of the BAR which will be submitted to the Department of Economic Development, Tourism and Environmental Affairs (EDTEA).

The I &APs include, but not limited to landowners, tenants, municipal and provincial authorities, interest groups, Non-Government Organizations and conservation groups.

This document details how you can become involved in the project, receive information and raise any issues of concern or interest regarding the proposed project. The sharing of information forms the basis of the Public Participation Process and offers you the opportunity to become actively involved in the project from the outset. Input from I&APs ensures that all potential environmental issues are considered within the context of the proposed project.

STUDY AREA

The site co-ordinates are as follows; start (28°5'25.13"S&31°53'24.65"E), to the river and then crosses the river at (28°5'25.03"S&31°53'23.09"E) and the ends at (28° 5'25.43"S&31°53'21.72"E).

PROJECT DESCRIPTION

The project entails the construction of a $64m \log x 5m$ wide road; 32m on both sides of the a river and the construction of a culvert causeway that will be $15m \log x$ 4.8m wide x 2.1m in height, to assist on the part of the road that is separated by the river.

A Basic Assessment Report (BAR) is an effective planning and decision-making tool, which allows for the identification of potential environmental consequences of a proposed project, and its management through the planning process.

WHY IS BASIC ASSESSMENT REQUIRED?

In terms of to the National Environmental Management Act, 1998 (Act No.107 of 1998), as read with the Environmental Impact Assessment (EIA) Regulations of 04 December 2014. an Environmental Authorization must be obtained from the relevant decision-making authority, the Department of Economic Development, Tourism and Environmental Affairs (DEDTEA), prior to the commencement of certain listed activities that may result in potential negative impacts on the environment.

The proposed activity triggers the following listed activity in Listing Notice 1 and 3 (GNR 983 and 985, 04 December 2014).
