MOTIVATING MEMORANDUM

EXHUMATION OF ASHES AND RELOCATION OF MEMORIAL STONE: VERITY DIGNA SHARP

Introduction:

West Rand Heritage Consultants had been appointed by Netcare Property Holdings (Pty) Ltd to apply to the relevant heritage authority for a permit for the exhumation of the ashes of Verity Digna Sharp at the Netcare Garden City Hospital, situated at 35 Bartlett Road, Mayfair, Johannesburg.

The ashes are buried in the garden next to the High Care Facility at the Hospital. The exhumation of the ashes is necessary to make room for the expansion of the High Care Facility. According to the memorial stone a tree was planted together with the ashes of Verity Digna Sharp in 1986. She was the first matron of the Garden City Clinic.

Biographical information: Verity Digna Sharp:

Information on Verity Digna Sharp is limited to the information on the memorial stone. Nobody came forward with more information on her life as a result of the Public Notices in the newspapers and as displayed at the hospital. However, information obtained from the database of the Genealogy Association of SA indicates that she was born Lorentz on the 28th December 1923. She died on the 31st December 1986. (<https://www.gendatabase.com/surname-name-index.php?q=SHARP>) She was the daughter of Dirk Frederick Karel Lorentz and Dorothy Hope-Poole. She was married to Kenneth Henry Sharp (born 19 December 1922) and filed for a divorce in 1964 (SANIAS: TAB/ULD Vol.0 Ref.635/1964). They have one child, Susan Verity Sharp, married to Ronny Smit. The latter couple do have two children, namely Shaun and Stacey.



No contact could be established with the descendants of Verity Digna Sharp in order to discuss the exhumation and relocation of the ashes. Various searches without success on Facebook and other social groups were launched apart from the newspaper notices.

Compulsory public notice:

The compulsory public notice informing the public at large of the intended exhumation and relocation of the ashes appeared in Beeld and The Star on the 24th January 2020. Nobody responded to it with the result that the notice has been re-advertised in the newspapers on Friday 28th February for another compulsory window period of 30 days. Nobody from the public nor the above mentioned descendants of the deceased responded to the public notice.



The notice was also published on the Heritage Portal of the 17th February 2020, with no results.

Current staff at the hospital could also not provide more information on the history or background of the deceased.

Professional services:

The following compulsory professional services were lined up for the exhumation and relocation of the ashes and memorial stone.

Act the exhumation must be done under the supervision of an acknowledged archaeologist. Their quotation was accepted by Netcare Property Holdings.

- The quotation from Immaculate Tree Services was accepted by Netcare Property Holdings for the removal of the tree and the tree stump.
- The quotation from Mr Nantie Croucamp from AVBOB (Johannesburg) for the “funeral services” related to the exhumation and re-burial was accepted by Netcare Property Holdings.
- The local Police Services will be informed of the exhumation and re-burial, if necessary, as soon as a date for the exercise is confirmed.



Grave Site


The grave site is situated in the garden next to the Garden City Hospital's High Care Facility along Bartlett Road in Mayfair, Johannesburg.



A granite memorial stone next to a tree in the garden states that the tree was planted together with the ashes of Verity Digna Sharp. The stone is today still partly free standing from the stump, however the bark grew over a top section.



The tree was identified from its leaves to be a Camphor Tree (*Cinnamomum Camphora*). The camphor tree is a large evergreen tree, slowly growing to over 40' tall and possibly 50+ feet wide, forming a broad rounded canopy. Large upright spreading primary scaffold branches often arc down with age. Leaves evergreen simple, alternate, 2-3" long ovate to elliptical shaped, long pointed tip, margins entire, waxy texture, shiny, light green almost yellowish in color. Camphor smell with crushed. They have 2 glands on the leaf at the intersection of the main vein and the 2 distinct laterals.

No information on the cremation or burial of the ashes of Verity Digna Sharp could be traced. The Netcare Garden City Hospital is situated on the original site of the Bridgman Memorial Hospital, later known as the Garden City Clinic. The Bridgman Hospital was closed in 1963 by the apartheid authorities on the grounds that it catered to predominantly Black patients in a White area. Garden City Investment (Pty) Ltd obtained the site of the Bridgman Hospital in 1988 (Title Deed T1278/1988). Sections of the original hospital were incorporated into the Garden City Clinic, however due to extensive developments and alterations to the site, none of the architectural significance of the original building is still evident

Ownership of the Garden City Clinic was transferred in 2001 into the name of Park Lane Clinic (Pty) Ltd under Title Deed T23531/2001 and in 2006 into the name of Netcare Property Holdings (Pty) Ltd under Title Deed T2105/2006. The record from previous owners were according to the hospital manager destroyed and not available for research purposes.

Closure:

Netcare Holdings decided to exhume the ashes to make room for the expansion of the High Care Facility at the Garden City Hospital. The ashes will be re-interred at the nearby municipal Brixton Cemetery. The memorial stone will be relocated to a site on the Garden City Hospital premises, yet to be identified.

Site Description

Well-known American missionary couple and activists Frederick Brainerd Bridgman (1869 – 1925) and Clara Davis Bridgman (1872 – 1956) were key figures in the establishment of institutions in aid of Black and Coloured communities. He was instrumental in the founding of the Helping Hand Club in Jeppestown, together with Henry Melville Tabert and Howard Pim the Bantu Men's Social Club in 1924 and with Dr. Ray Phillips the Jan Hofmeyr School of Social Studies – the first institution to train Black social workers in South Africa. According to a Wikipedia entry, alumni of the school included Gibson Kente, Ellen Kuzwayo, Winnie Mandela, Joshua Nkomo, Louis Petersen and Eduardo Chivambo Mondlane. Frederick also began a clinic for migrant mine workers with the intention of eventually establishing a hospital. However, he died in 1925 during a visit to the USA and the work of fundraising passed to his wife, Clara. She raised the funds required and the Bridgman Memorial Clinic opened in 1928. In the early days prominent figures involved on the General Committee of the hospital included Charlotte Maxeke (representing the African Methodist Episcopal Church) and Dr. A.B. Xuma (Bridgeman Memorial Hospital, Annual Report for the year 1936, retrieved from http://www.historicalpapers.wits.ac.za/inventories/inv_pdfo/AD1715/AD1715-9-7-1-2-006-jpeg.pdf on 25 February 2016). Clara Bridgman retired in 1941 to the States and died in 1956. Well known personalities with ties to the hospital included Basil Sipho Neo Bridgeman Bikitsha, affectionately known as "Doc" Bikitsha, who was born here in 1930. He was awarded the Order of Ikhamanga in Silver for his contribution to journalism and literature.

In 1963 the hospital was closed by the apartheid authorities on the grounds that it catered to predominantly Black patients in a White area. In 1967 the Bridgman Clinic was founded in Zola Soweto from the moneys received after the expropriation of the Bridgman Memorial Hospital (UCCSA Congregational Chronicle 2013: Serving Soweto: Telling the Story of Bridgman Centre by Rev. D Nxumalo and Wellington Mthobisi Sibanda). The Garden City Clinic stands today on the same site. While some of the sections of the original hospital were incorporated into the Garden City Clinic, however due to the extensive developments and alterations to

the site, none of the architectural significance is still evident.





Fig. 1 According to hospital management this is the only visible remaining section of the original hospital




Fig. 3 Bridgeman Memorial Hospital, circa 1936
