### RECORD OF DECISION

Amongst other things, the following was discussed:

- The material was excavated in 2016/17 and consists of sediments only; these are listed in detail.
- The dating is to be carried out in Australia in the same laboratory as previously in order to be consistent.

### DECISION:

The application to perform OSL dating on sediments from PP5-6 is approved.
