You are reminded that failure to comply with the requirements of the Standard constitutes an offence in terms of section 49A of the National Environmental Management Act, 1998 (Act No. 107 of 1998), as amended.

In terms of point 18 of the Standard, you are instructed to notify all registered interested and affected parties, in writing and within fourteen (14) days of the date of this letter, of the registration, as well as provide them an opportunity to appeal.

In terms of the Promotion of Administrative Justice Act, Act No. 3 of 2000, you are entitled to the right to fair, lawful, and reasonable administrative action; and to written reasons for administrative action that affects you negatively. Further, your attention is drawn to the provisions of the Protection of Personal Information Act, Act No. 4 of 2013 which stipulate that the Department should conduct itself in a responsible manner when collecting, processing, storing, and sharing an individual or another entity's personal information by holding the Department accountable should the Department abuse or compromise your personal information in any way.

Your attention is drawn to Chapter 2 of the National Environmental Management Act, Act No. 107 of 1998 National Appeal Regulations published under Government Notice R993 in Government Gazette No. 38303 dated 08 December 2014 (National Appeal Regulations, 2014), which prescribes the appeal procedure to be followed. Kindly include a copy of this document (National Appeal Regulations, 2014) with the letter of notification to interested and affected parties in this matter.

Should any person wish to lodge an appeal against this registration, he/she must submit the appeal to the appeal administrator, and a copy of the appeal to the applicant, any registered interested and affected party, and any organ of state with interest in the matter within 20 days from the date that the notification of the registration was sent to the registered interested and affected parties by the applicant; or the date that the notification of the registration was sent to the applicant by the Department, whichever is applicable.

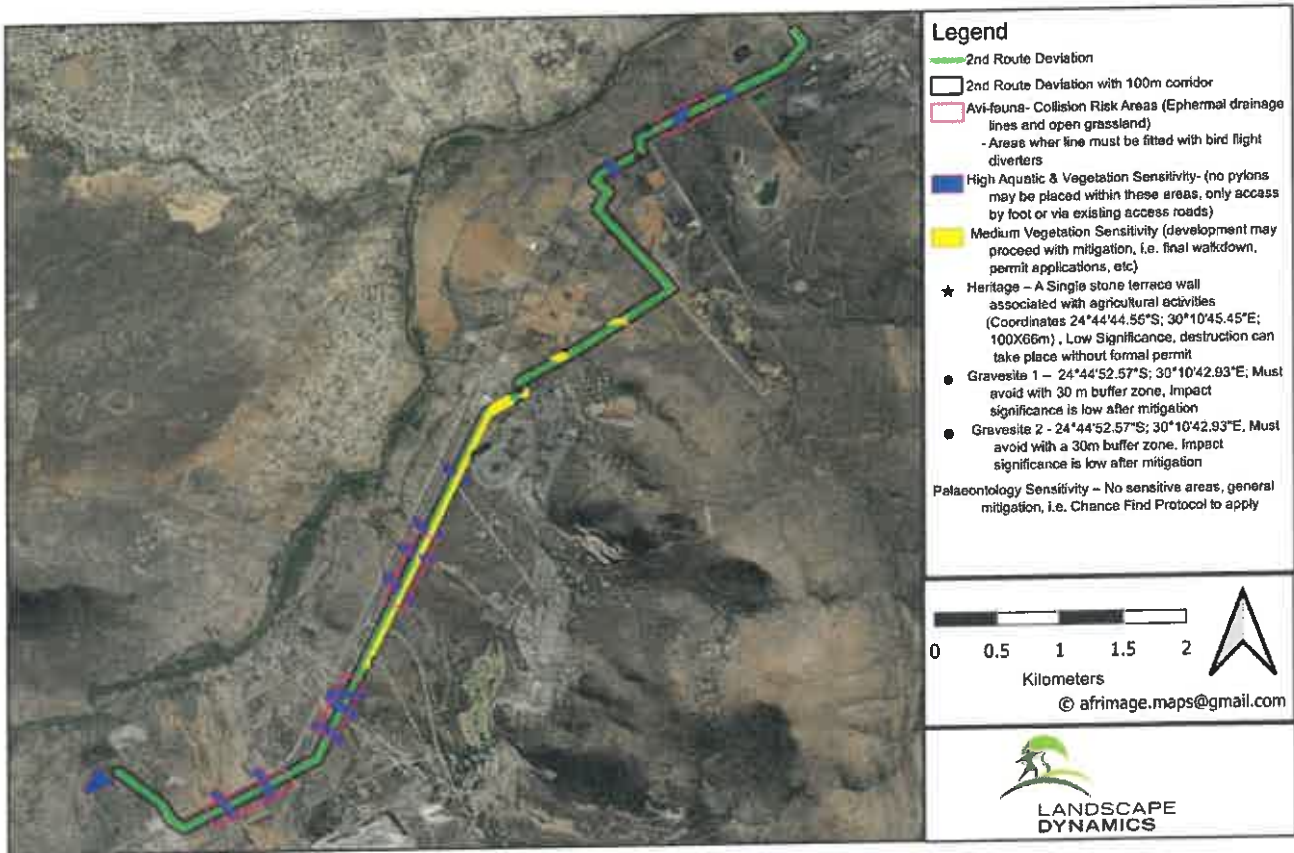
