1. Attached, please an invoice from Spoornet for R0,11 for the hire of the access road to the grave of Gordon Nourse in Adelaide.

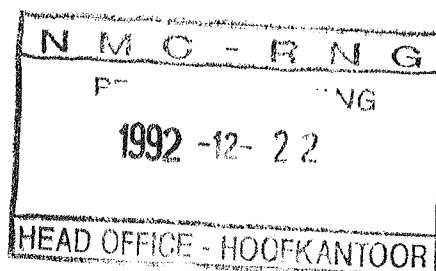

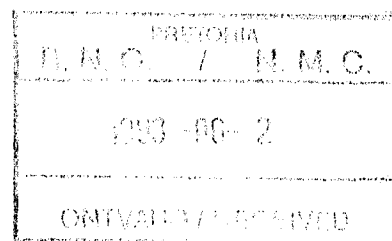

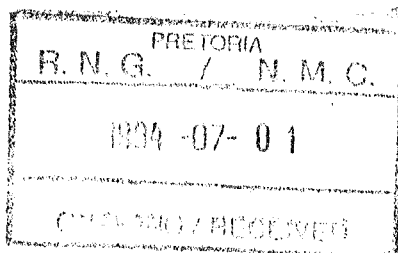
