

NOTICE OF A WATER USE LICENCE APPLICATION

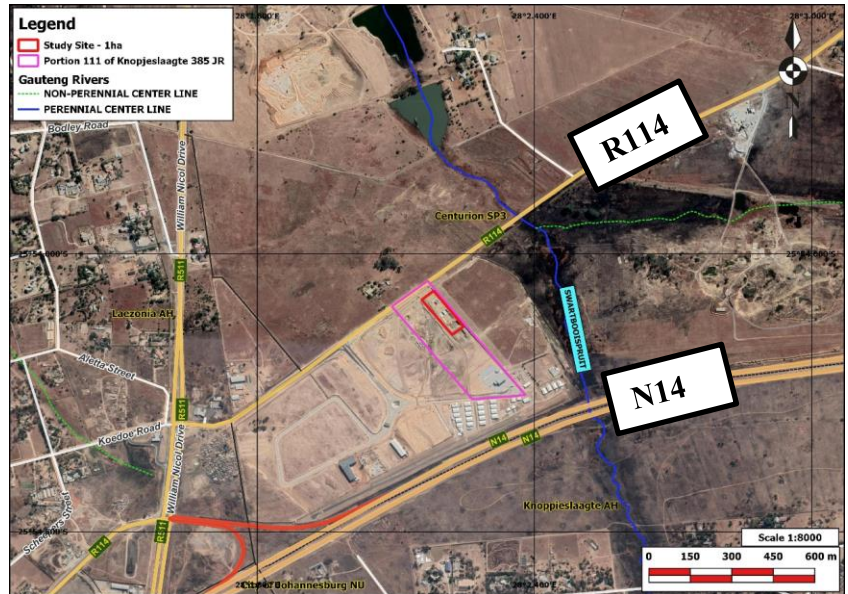
Notice is hereby given that a Water Use Licence Application (WULA) Registration in terms of the National Water Act (NWA), 1998 (Act No. 36 of 1998, as amended) and the Regulations regarding Procedural Requirements for Water Use Licence Applications and Appeals, 2017, will be lodged with the Department of Human Settlements, Water and Sanitation (DHSWS).

Project Name: Peach Tree X25 Waste Water Treatment Plant

Proponent: Nisagyn (Pty) Ltd

Project & Property Description: It is the intention of Nisagyn (Pty) Ltd to construct a Waste Water Treatment Plant (WWTP) on Portion 111 of the Farm Knopjeslaagte 385 JR.

Location: The proposed WWTP will be located towards the north-eastern boundary of the Peach Tree X25 Development. The site for the proposed industrial development is located between the R114 (to the north) and the N14 freeway (to the south). The Eagles Creek Aviation Estate is situated towards the eastern and southern boundaries of the study area. Aeroplane hangars and a landing strip occurs to the south. Diepsloot residential settlement is located approximately 2km south-west of the site.



A Water Use Licence Application (WULA) Registration in terms of the NWA and its associated Regulations will be submitted to the DHSWS.

NWA Section 21 Water Uses which may be triggered:

Section 21 (c): Impeding or diverting the flow of water in a watercourse;

Section 21 (f): Discharging waste or water containing waste into a water resource through a pipe, canal, sewer, sea outfall or other conduit;

Section 21 (g): Disposing of waste in a manner which may detrimentally impact on a water resource; and

Section 21 (i): Altering the bed banks, course or characteristics of a watercourse.

Date of Notice: 12 March 2020 – 14 April 2020 (Excluding Public Holidays)

The proposed WWTP triggers activities as listed in Section 21 of the NWA, and Interested and Affected Parties (I&APs) are invited to register with the contact person below. All registered I&APs will be allowed **60 days** to comment on the **WULA** upon release of the documentation. Representations with respect to this application may be made by phone, fax or e-mail.
