It was noted that:

1. The applicant has notified the Northern Cape Heritage Resources Authority of the location, nature and extent of the proposed development.
2. The applicant has submitted an application for:
  - ❖ Restoration of the Anglo- Boer War Blockhouse, at Warrenton.
  - ❖ Cleaning of the area surrounding the block house.
  - ❖ Erection of a fence to cordon off the blockhouse.
3. The Provincial Heritage Resources Authority (NCHRA) assessed the grading of the structure and concluded that:
  - ❖ It dates from the Anglo-Boer War of 1899 to 1902.
  - ❖ It is protected under section 30 and 34 of the National Heritage Resources Authority, together with the portion of land in front of the building, extending as far as the road reserve boundary, and including one metre of land on the sides at the rear thereof, situated on a portion

of Water Erf 8, Block Y (known as Erf: 381, Warrenton) in the Municipality of Warrenton, Division of Kimberley.

- ❖ It is of high provincial significance.

**Comment:**

1. The Northern Cape Heritage Resources Authority approves the restoration of the Anglo Boer War (1899-1902) Block House, at Warrenton and recommends that no deviation from the proposed plan/work should be followed.
2. The notice of development should be advertised in the local newspapers.
3. The committee further recommends that a report on work done under authority, regarding monitoring of work be submitted under authority of this permit.

**Please note the following:**

- The decision is subject to an appeal period of 14 working days.
- The appeal period shall be taken from the date when the applicant is informed.
- It should be noted that for an appeal to be deemed valid it must refer to the decision, it must be submitted by the due date and must set out the grounds of appeal.
- The permit may be suspended should appeal against this decision be received by Provincial Heritage Resources Authority within 14 days from the date the record of decision is issued.
- The permit may be cancelled, nullified and reversed should the applicant not adhere to the conditions as set out above.
- Work may not be initiated during this 14 day appeal period.
- The issuing of a permit does not exonerate the applicant from obtaining any other approval for the proposed work.
