NOTICE OF THE ENVIRONMENTAL AUTHORISATION PROCESS FOR THE AMENDMENT OF THE WATerval MINE ENVIRONMENTAL MANAGEMENT PROGRAMME REPORT TO INCLUDE THE PROPOSED UG1 OPENCAST PROJECT AND PR 2060 INTO THE MINING RIGHT AREA, AND THE ASSOCIATED WATER USE LICENCE APPLICATION

AVAILABILITY OF THE DRAFT ENVIRONMENTAL IMPACT ASSESSMENT AND ENVIRONMENTAL MANAGEMENT PROGRAMME REPORT FOR PUBLIC COMMENT

Applicant: Glencore Operations South Africa (Pty) Ltd – Waterval Mine
Location: Remaining extent of Portion 82 of the Farm Waterval 306 JQ near Rustenburg, North-West Province

Project description:
 Glencore Operations South Africa (Pty) Ltd (Glencore) is the owner of the Waterval Mine located ~3 km east of Rustenburg in the North-West Province. Glencore proposes to amend its approved 2021 Consolidated Environmental Management Programme (EMPr) for the Waterval Mine to include the UG1 opencast project, as well as to include Prospecting Right Area 2060 into the existing mining right area. The proposed UG1 opencast project will include an opencast pit and supporting infrastructure. Waterval Mine has appointed Alta van Dyk Environmental Consultants cc (AVDE) as the Independent Environmental Assessment Practitioner to undertake the required environmental-related applications and associated public participation process.

Authorisations required:
 Before Waterval Mine may commence with the development of the proposed UG1 opencast project, the following environmental authorisations are required:

- A Scoping and Environmental Impact Reporting (S&EIR) process in terms of the National Environmental Management Act (Act 107 of 1998) (NEMA) and the Environmental Impact Assessment (EIA) Regulations (2014, as amended). The competent authority for this process is the Department of Minerals and Energy (DMRE). The following listed activities are triggered: Listing Notice 1 (GNR 983): 12(ii), 19, 21D, 24, 27; Listing Notice 2 (GNR 984): 6, 17; Listing Notice 3 (GNR 985): 4, 12, 14.
- Approval in terms of the National Environmental Management: Waste Act (Act No. 59 of 2008) (NEM:WA) (a combined application in terms of NEMA and NEM:WA to be submitted to the DMRE). The following activities are triggered: Category B (GNR 921): 7, 10, 11.
- A Water Use Licence Application (WULA) in terms of the National Water Act (Act 36 of 1998). The competent authority for this process is the Department of Water and Sanitation (DWS). The following Section 21 water uses will be applied for: Section 21 (a), (c), (g), (i) and (j).

Availability of Draft Environmental Impact Assessment and Environmental Management Programme Report (EIA/EMPr):
