Please find attached the revised draft EIA Report and associated appendices in relation to the application for the Environmental Authorisation (EA) for the establishment of the Proposed Gas to Power via Powership Project at the Port of Richards Bay, uMhlathuze Municipality within King Cetshwayo District Municipality, KwaZulu-Natal.

On the 3rd of May 2023, condonation was granted for the late submission of the revised EIAr and a period of sixty (60) days from the date of the decision letter was allowed for a further public participation process ("PPP") to be conducted, in order to provide registered I&APs with additional opportunity to comment on the revised EIAr.

This revised draft EIA Report for the Gas to Power via Powership Project at the Port of Richards Bay has been compiled in accordance with the Environmental Impact Assessment Regulations, 2014 (as amended) and the National Environmental Management Act 107 of 1998 (as amended).


