AMENDMENT OF THE ENVIRONMENTAL AUTHORISATION ISSUED ON 25 JANUARY 2013 FOR THE CONSTRUCTION OF THE 75MW OLYVEN KOLK FARM 4 PHOTOVOLTAIC POWER PLANT ON THE REMAINING PORTION 14 (A PORTION OF PORTION 4) OF THE FARM OLYVEN KOLK WITHIN THE SIYANDA DISTRICT MUNICIPALITY, NORTHERN CAPE PROVINCE

The Environmental Authorisation (EA) issued for the abovementioned application by this Department on 25 January 2013, the amendments to the EA dated 07 August 2013 and 06 November 2015, and your application for amendment of the EA received by the Department on 23 January 2018, refer.

Based on a review of the reason for requesting an amendment to the above EA, this Department, in terms of Chapter 5 of the Environmental Impact Assessment Regulations, 2014 as amended, has decided to amend the EA dated 25 January 2013 as amended, as follows:

Amendment 1: Amendment to extend the validity period of the EA:

The activity must commence within a period of five (05) years from the date of expiry of the amendment to the EA issued on 06 November 2015 (i.e. the EA lapses on 25 January 2023). If commencement of the activity does not occur within that period, the authorisation lapses and a new application for environmental authorisation must be made in order for the activity to be undertaken.

The applicant applied to extend the validity period of the EA due to Eskom's refusal to sign the power purchase agreements. As such, as the applicant is yet to obtain preferred bidder status for the project from the Department of Energy, the applicant has applied for an extension of the validity period of the EA.

This proposed amendment letter must be read in conjunction with the EA dated 25 January 2013 as amended.

In terms of Regulation 4(2) of the Environmental Impact Assessment Regulations, 2014 (the Regulations), you are instructed to notify all registered interested and affected parties, in writing and within 14 (fourteen) days of the date of the Department's decision in respect of the amendment made as well as the provisions regarding the submission of appeals that are contained in the Regulations.

Your attention is drawn to Chapter 2 of Government Notice No. R.993, which prescribes the appeal procedure to be followed. Kindly include a copy of this document with the letter of notification to interested and affected parties.

Should any person wish to lodge an appeal against this decision, he/she must submit the appeal to the appeal administrator, and a copy of the appeal to the applicant, any registered interested and affected party, and any organ of state with interest in the matter within 20 days from the date that the notification of the decision was sent to the registered interested and affected parties by the applicant; or the date that the notification of the decision was sent to the applicant by the Department, whichever is applicable.


