NOTICE IN RESPECT TO TRANSNET PORT TERMINAL TRIAL TO HANDLE AND STORE IRON ORE (HEMITTE)

Transnet Port Terminals (TPT) operate and handle bulk and breakbulk at the Multi-Purpose and Bulk Terminals in the Port Richards Bay, Kwazulu Natal. The facility receives and stockpiles cargo in the port from various clients and mining operations arriving via road or rail.

TPT is in possession of an Atmospheric Emission Licence (AEL) in terms of Section 40 of the National Environmental Management: Air Quality Act 39 of 2004 (NEM: AQA) issued on the 17th August 2018.

This notice serves to inform parties that may be interested or affected by the TPT trial to store and handle Iron Ore -Hematite. Transnet Port Terminal will handle and store and export hematite with a maximum capacity of 400 000 tons and at the back of the port, and the maximum capacity of 55 000 tons stored in the port for a period not exceeding four months.

The trial to store and handle hematite commenced on the 07th May 2021 and ends on the 3rd September 2021 which is 120 days granted by the authorities - King Cetshwayo District Municipality.
