## 1. OPEN AND INTRODUCTION

Matthew Hemming (MH) opened the meeting and introduced SLR Consulting (South Africa) (Pty) Ltd (SLR). MH then introduced Phillip Steyn (PS) representing Rhino Oil and Gas South Africa (Pty) Ltd as the applicant. MH thanked everyone for their attendance, asked that all complete the attendance register and confirmed that the meeting will be conducted in English. Given the small size of the meeting all participants were asked to introduce themselves.

MH indicated that this meeting was being held with the Traditional leaders and ward councillors as representatives of the community who own land/reside in the application area. He indicated that this meeting was a part of the first round of engagement that was being undertaken for the scoping and EIA process required for the ER application.

## 2. PRESENTATION

MH gave a slide presentation outlining the environmental process, the project scope, project alternatives, the current state of the environment, potential anticipated impacts, the way forward in this environmental process and the logistics for report distribution. PS gave a presentation outlining the structure of Rhino Oil and Gas South Africa and the activities that are proposed to be undertaken for

the exploration. The physical activities include core borehole drilling and seismic surveys. See the presentations attached in Appendix 2.

## 3. DISCUSSION

A number of issues were raised during the meeting. Many of these related to clarification of the presentations, how long takes to get approval, how long the exploration takes etc. The key issues have been recorded in Table 1 below. Where a response was provided the response has been included in the table. It was highlighted at the meeting that the EIA is in its early stages and as such not all answers to issues raised were available.

Hence today's meeting.</p> <p>A further round of engagement will be undertaken during the EIA process and we will consider suggestions on where and with whom to hold these. Socio Economic	<p>Communities must benefit or they will revolt against the project as has happened in the North West .</p> <p>While the law may be based in Pretoria, the activity will be here, amongst the people. Mining wont happen if the people don't let it.</p>	Traditional Leader, Scoping Meeting	<p>The purpose of the current consultation is to understand the issues and impacts that the project could have on the environment. Communities are part of this environment and are therefore being consulted. It was explained that the MPRDA does provide that mining companies must take note of communities and ensure that the benefits of mining accrue locally. This is facilitated through a Social and Labour Plan.</p> <p>However, it must be noted that the Social and Labour Plan is only required for the production phase of a project, not during exploration.</p> <p>In the exploration phase of a project there is no income and thus no benefits can accrue.</p>
Biodiversity	<p>There is work being done to improve the ecology of this region? Although protected areas are excluded, what about future conservation areas.</p> <p>The Matatiele Local Municipality is working toward expanding protected areas through a biodiversity stewardship programme. This has been aligned with the Provincial Protected Area Expansion Strategy</p>	Ward Councillor, Scoping Meeting	<p>We are aware of existing protected areas in the area and these are specifically excluded. Part of the scoping process is develop an understanding of the biodiversity status and sensitivity of the area. MH used various maps to indicate different resources that had been accessed (EC Biodiversity Conservation Plan, NPAES). We are also aware that the some the planning area of the MDTCA is located here. We would be interested to obtain details on the areas that are likely to be declared as protected.</p>

#### **4. THE WAY FORWARD**

The way forward agreed to by attendees was outlined as follows by MH:

- Distribute draft scoping report (from mid October 2015)
- Regulatory authority and public review (30 days).
- Summaries to be made available in Xhosa and Sotho.
- PASA to decide on scoping (January 2016)
- Specialist EIA investigations (next 3-5 months)
- Distribute draft EIA and EMP report (~ April 2016)
- Distribute record of decisions (~ 3<sup>rd</sup> quarter 2016)

#### **5. CLOSE**

MH thanked attendees for their input and for making the time to attend the public scoping meeting. He advised that there will be further communication with the registered I&APs and that another round of public meetings was likely to be held early in 2016. The meeting was closed.
