Location: The River Ridge Resort developed between an irrigation canal (the irrigation canal which flows through the entire Upington and which is regarded as the flood line) and Orange River right bank on Erf 3119 at Kameelmond some 15km west of Upington: on the southern side of the R27 Route; and found between Upington and Keimoes, Erf 3119 and surrounding erven, some in private possession and others forming part of the Upington commonage, are currently zoned as agricultural land.

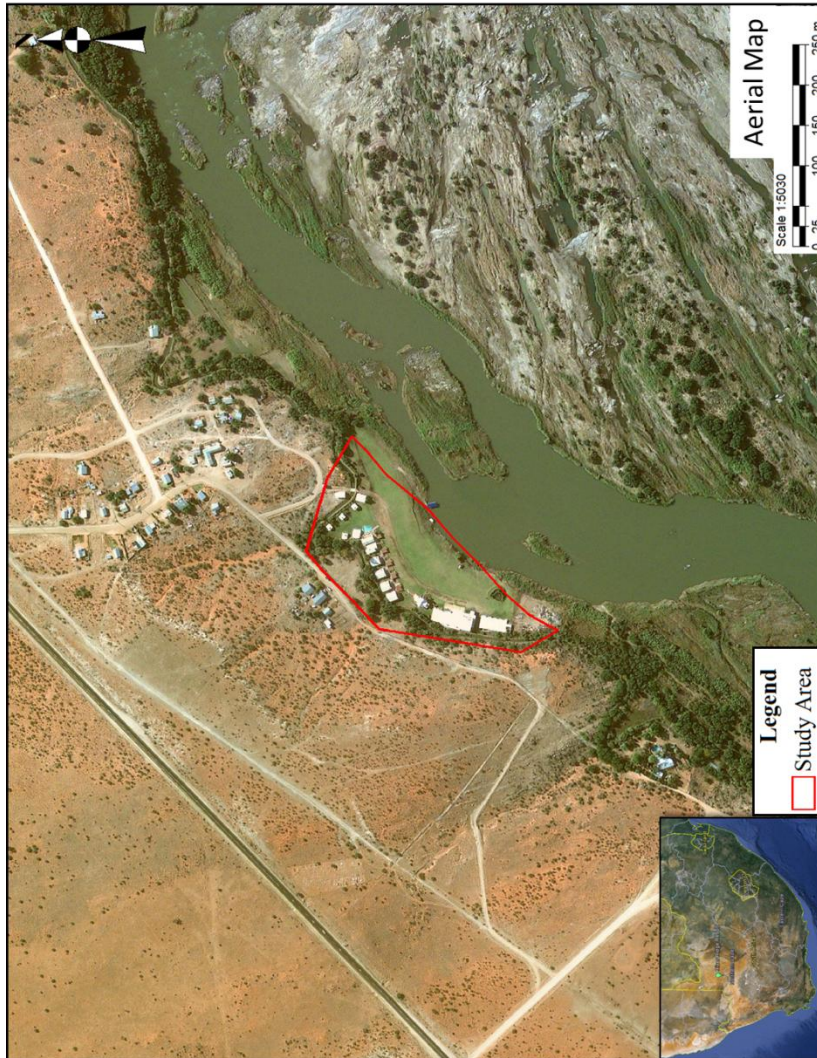
