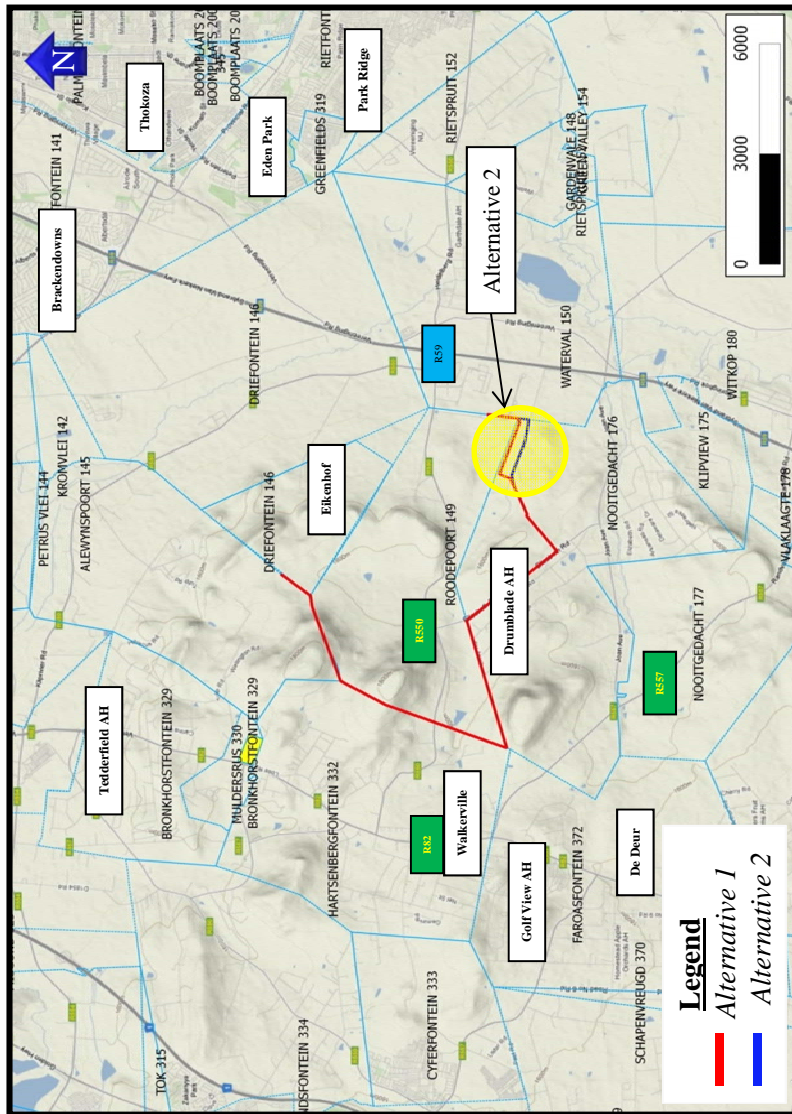


Blue Rose Development: Bulk Electricity Supply

NOTICE OF BASIC ASSESSMENT PROCESS

Notice is given of an application for a **Basic Assessment Process** that was submitted to the National Department of Environmental Affairs, in terms of Regulation No. R543 published in the Government Notice No. 33306 of 18 June 2010 of the National Environment Management Act, 1998 (Act No. 107 of 1998) governing **Basic Assessment Procedures (Notice 1 – Governing Notice R544)** for the following activity:

Property Description: Blue Rose Electricity infrastructure situated on Portion 6 of the farm Waterval 150 IR, Remainder and Portion 3 of the farm Roodepoort 149 IR, Remainder and Portion 279, 32, RE, 1, 2, 8, 10, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30 and 31 of the farm Nooitgedacht 176 IR, Remainder and Portion 30, 12, 13 and 24 of the farm Hartsenberfontein 332 IQ and Remainder and Portion 42, 143, 37, 38 of the farm Alewynspoor 145 IR.

Length of ±17.64km.
