

## Project & Property Description:

The proposed external services upgrades are for water, sewer and electricity. This infrastructure will service the approved Stone River Arch development as well as future developments in the area. The alignments of these upgrades services traverse Portion 112 and the Remaining Extent of Portion 2 of the farm Rietvlei 101 IR as well as Portion 28 and Remaining Extents of Portion 1 and 6 of the farm Liefde en Vrede 104 IR.

Location: The proposed infrastructure is situated south-west of the Malburton suburb and on both sides of Klip River Drive. The Aspen Hills Nature Estate is situated just to the south of the study area. The Glenvista and



Glenanda suburbs are located to the north of the study area. The stream subject to the services crossings is a tributary of the Klip River. The water and electricity alignments will cross this stream whereas the sewer will merely connect to a manhole in the buffer of this stream.
