RE: PUBLIC PARTICIPATION PLAN: MIDDEL POST NO. 60

The public participation process to be followed is inclusive of the following aspects:

- 1) All IAP's are identified according to the regulations and may include, but are not limited to:
 - Adjacent land owners
 - Land owners in close proximity to the proposed prospecting activities
 - Organs of state
 - Traditional leaders within the area
 - Should any person, in terms of regulation 41(2)(e), be identified the following measures will be implemented:
 - o Illiteracy A meeting will be arranged where the project will be explained.
 - Disabled A meeting venue will be arranged, in the case of such meeting request, which can accommodate such a person.
- 2) An IAP's registry will be used to keep record of the consultation process. A list of preidentified IAP's are attached below. Once the project is advertised all other IAP's will be added to the list.
- 3) Identified IAP's will either be contacted via telephone, email, fax etc.
- 4) The following documents will be sent to the identified IAP's:
 - Notice of Proposed Mining activities
 - Background Information Document (BID), which includes a locality map and current site layout map.
- 5) A notice will be published in the local newspaper that includes the details of the proposed activities and site location. The notice will also stipulate that a public meeting will only be held upon request of the public and only if the request is made by three or more persons, will it be a contact meeting. If only one or two members of the public request a meeting the meeting will be held virtually via: Zoom, Teams etc. The notice will also indicate the date of availability of the Draft Basic Assessment (BAR) report and the platforms on which it will be made available.
- 6) All comments will be incorporated into the Draft BAR and submitted to the authority as a Final report.
