Dear Ms Mofutsanyana,

Thank you for the below correspondence.

1. Supply chain management (SCM) has recently advised on a hold on advertisement and appointment of service providers through its official electronic procurement system (ePS) (attached). At this time no indication has been given of when the service will resume.
2. As the estimated costs are above the limit of the '3 quotation' system mentioned by SCM, Mechanical Services will need to utilize the ePS procurement platform when it is re-opened, or seek approvals for appointment outside of this system. As such, a definite timeline for appointment of the conservator is challenging to provide.
3. All efforts to appoint a conservator and perform the process as required by SAHRA will continue as far as possible however, a kind request for a 12 month extension is submitted. The extension will allow the department to navigate the process given the current constraints.
4. Please can SAHRA also assist in confirming if the scope of work (listed activities) quoted for in the attached is aligned with the expectations of SAHRA for the old pont. Thank you.

The meeting at the pont yesterday re. the application to decommission the old pont refers. We would like to thank SAHRA for their time yesterday and assistance going forward.

The following items were agreed upon:

1. A public participation process is required prior to final arrangements being made for the old pont.
2. SAHRA to please send a confirmed list of stakeholders who must be involved in the public participation process.
3. SAHRA to please assist in providing recommendations for a conservator or suitable consultancy who may be appointed by the Department of Transport and Public Works (DTPW).
4. The conservator will be appointed to conduct an assessment and draft a conservation management plan. Their expert opinion and report will serve as input towards the public participation process.
5. DTPW and ODM to ensure basic maintenance/cleaning is performed on the old pont to slow down further degradation at its current location.

Once input information is received, the process to appoint a conservator and inform all relevant stakeholders of the public participation process will follow.
