RE: Application for Phase II mitigation (measuring, mapping, excavation and data analysis) of historic settlement stonewall foundations and midden on Erf 6861 of Pietersburg, Extension 30, Polokwane, Limpopo Province, South Africa

As per our telephone conversation, my name is Nkosinathi Godfrey Tomose from NGT Infraco (Pty) Ltd. We are a cultural resources management (CRM) company based in Johannesburg, Gauteng Province. We are appointed by Nemai Environmental Consultancy to undertake a Phase II Archaeological Mitigation for archaeological sites situated within the Limpopo Central Hospital development footprint northeast of Peter Mokaba Stadium. In terms of surveyor general information, the sites are within Erf 6861 of Pietersburg, Extension 30, Polokwane and include stonewall enclosures and ash middens. The archaeological sites were first discovered in 2019 during a Phase I Archaeological Survey on-site by PGS Heritage (Attachment 01: Phase I HIA Report). We have applied for a Phase II Archaeological Mitigation permit with the South African Heritage Resources Agency (SAHRA) for the mitigation of the sites. The SAHRA requires us to have a repository centre (i.e. a museum or research institution) for housing and curating the archaeological findings post the mitigation programme. The priority sites include:

- LIM-09 and LIM-08, i.e., stonewall enclosures, which are situated within the development footprint and in need of urgent mitigation for site clearance and site establishment.
- LIM-06 and LIM-07 which are on the boundary of the development footprint may be directly and indirectly affected by site clearance and site establishment.
- We will also test the rest of the sites which include LIM-03, LIM-04 and LIM-06 to understand the distribution patterns for scientific reasons and make inferences about the entire settlement.

We would like the assistance of Polokwane Museum to house the material at its institution facilities and for the curation. Following the mitigation process, NGT Infraco will furnish the institution with all the findings (archaeological material culture) clearly labelled and packaged, maps and sketches of the sites and the trenches established, photographic material, field notes and the final Phase II Mitigation report and permit to be issued by SAHRA on the project.

From your side, SAHRA will require a letter (on your institution's letterhead) stating that the Polokwane Museum will grant us permission to house and curate the material on a long-term basis. Thank you once more in advance for your willingness to assist in this regard.
