HWC therefore puts the attached documentation to SAHRA for assessment and to consider the subject property for Grade I status.

# **Provincial Heritage Site Nomination Form**

This form precedes the submission of the 'Nomination Document' and is designed to assist with the grading of heritage resources in terms Section 3(3) of the National Heritage Resources Act, as part of the process of declaration as a Provincial Heritage Site (Section 27). Nominated heritage resources that are of special provincial significance will be graded as Grade 2 and considered for Provincial Heritage Site status.

**Proposed Provincial Heritage Site:** 

Rocklands Community Hall, erf 11553, Cnr Lancaster Road and Parker Street, Rocklands, Mitchell's Plain, Cape Town

**Brief Statement of Significance:** 

The Rocklands Community Hall has been erected by the Cape Town City Council in in 1981 to serve as a multi-amenities hall for the community of Mitchell's Plain, most of whom that were relocated from District Six under the Forced Removals programme of the Apartheid system. Because of its central location and size, it is used for larger gatherings. In this instance it was the venue where the historic meeting was held that led to the establishment of the United Democratic Front (UDF) that was to have a profound influence on the democratisation of South Africa. The site is given added significance by the UDF Memorial that was erected by the City of Cape Town in front of the Hall. The NHR Act requires that a site must have sufficient significance to be considered for formal protection. The Rocklands Hall, though a modern building has sufficient significance in three respects, namely: political, architectural and social. The UDF Memorial is included in this proposal.

Political Significance:

The political significance of the Rocklands Community Hall in Rocklands, Mitchell's Plain, Cape Town is the most outstanding form of significance that would warrant its formal protection in terms of the NHR Act. This hall was the place where United Democratic Front (the UDF) was constituted on 20 August 1983. The UDF was a political organisation that was specifically formed to unite people over a broad spectrum, across racial, religious and social barriers, to resist the oppressive Apartheid political system. As an organisation the UDF was to play an invaluable role in sensitising ordinary citizens to resist the evils of the Apartheid system. There was consensus that unity was the only way to resist and break down the last vestiges of Apartheid which prevented the democratisation of South African society and its political system which deprived the voiceless masses from having a direct say in matters affecting them.

By the 1980s the fight for democracy in South Africa, which started with the Soweto Uprisings in 1976, was intensified. A huge rally was organized in the Rocklands Hall, in Mitchell's Plain to protest against the Tri-Cameral system, i.e. a parliamentary system proposed by the National Party government to create a system of government based along racial lines. Once again the majority of the population (read Black South Africans) was ignored and was not included in the proposed new governmental structure and was seen as another ploy to divide-and-rule. The protest rally was attended by about 10 000 people. What made the Rocklands gathering all the more significant was the presence of a large number of well-known anti-Apartheid veterans, e.g. Archbishop Desmond Tutu, Dr Allan Boesak and several 1950s activists, including Albertina Sisulu, Oscar Mpetha, Helen Joseph, Frances Baard, Archie Gumede and RD Naidoo. The leaders of the rally and those present expressed the view that the most effective way to combat and breakdown the evil system of Apartheid was through unity. The UDF was born from this resolution. The Rev Frank Chikane was the first speaker to address the gathering and called it the day "The turning point in the struggle for freedom". Delegates of 565 organisations from all over the country were part of the constitution of the UDF. Dr Alan Boesak, a prominent theologian and campaigner for democracy, led the steering committee.

After its establishment, the UDF was at the forefront of protest action and its members were largely responsible for the intensification and sustenance of resistance in the period from 1984 to 1986 by organising rent boycotts, school protests, workers stay-aways etc. At its peak the UDF had some 700 affiliates. The most important of these were students/youth organisation, trade unions, civic and women's organisations and church groups. Most of these bodies had a considerable influence in the communities in

which it operated and considerably contributed to the success of the UDF to become one of the important forces that contributed to the fall of Apartheid. As such the UDF should, in one way or another, be commemorated for its contribution in breaking down the stranglehold of Apartheid.

The City of Cape Town took the initiative to commemorate the role played by the UDF in dismantling Apartheid by erecting a memorial in front of the Rocklands Community Hall to commemorate the formation of the UDF in the Rocklands Hall. The UDF Memorial was unveiled on 20 August 2011 by the premier of the Western Cape, Ms Helen Zille, the Mayor of Cape Town, Ms Patricia de Lille, Dr Alan Boesak, one of the founding leaders of the UDF, and Mr Tony Ehrenreich, leader of the opposition in the Cape Town City Council. Commendable as the erection of the memorial may be, the community hall cannot be separated from the memorial as they are closely connected and should therefore be seen as one entity of great provincial, if not national, significance that deserves formal protection in terms of the National Heritage

Architectural and Social Significance:

The Rocklands Community Hall has a further, very different form of significance. The Rocklands Hall was one of eight identical halls built by the Cape Town City Council in low-cost areas of the Cape Flats in the 1970s and 1980s where many people affected by the Forced Removals of the Apartheid era, particularly those who had lived in District Six were resettled. It was intended to be a "people's place" to provide in the social / recreational needs of the people living in the area, most of whom were from the lower income group and therefore not able to provide such amenities of their own. The prototype of these "people's place" halls was the Westridge Community Hall that was designed by architect Graham Parker whilst being employed by the Cape Town City Council. The Rocklands Hall was based on the same design. Graham Parker (hence the street name) was awarded an architectural Award of Merit by the then Cape Provincial Institute of Architects for his design. As the result of the success of the design, a number of halls, based on this design were also built in other South African provinces. Ironically the Rocklands Hall, as a "people's place" would be intricately connected to the peoples' movement, amongst others the UDF, in which it was founded. This award once again establishes its significance and its connectedness to the memorial erected

The Rocklands Hall continues to serve its original purpose to be a "people's place" and the demand for the use of this hall is of such a nature, that bookings have to be made long in advance. Besides its recreational use, it is currently also used, amongst others, as a venue where people receive social grants, a meeting place for senior citizens, sports clubs, a crèche, church services etc.



# The area declared is that falling within the following boundary:

Commencing on the boundary of erf 11553 at the junction of Park Ave and Lancaster Road, the boundary runs south-east along the erf boundary on Park Avenue to a point opposite the southern corner of the Rocklands Civic Centre. From there it turns to the north-east and runs along the south-eastern wall of the Centre to a point in line with the southern-most corner of the Rockland Public Library, whereupon it turns to the north-west running along the sour-western wall of library to a point opposite to the south-eastern façade of the Rocklands Clinic and thereafter turning to the South-west running along the south-eastern and south-western façades of the clinic to a point on Lancaster Road whereafter it runs along the boundary of the erf to the junction with Park Avenue.

INVESTIGATION INTO THE PROPOSED DECLARATION OF ERF 11553, THE ROCKLANDS COMMUNITY HALL, CORNER LANCASTER ROAD AND PARKER STREET, MITCHELLS PLAIN, ROCKLANDS, CAPE TOWN AS A PROVINCIAL HERITAGE SITE IN TERMS OF SECTION 27 OF THE NATIONAL HERITAGE RESOURCES ACT (NHRA, ACT 25 OF 1999).

The matter above has reference.

The above matter was discussed at the meeting of the Inventories, Grading and Interpretation Committee (IGIC) of Heritage Western Cape held on 31 May 2017.

### In the discussion, amongst other things, the following was noted:

- A PHS nomination for this site was previously submitted by HWC in February 2013. This is a resubmission.
- The site has strong political, architectural and social significance.
- The site has a UDF Memorial erected by the City in front of the hall.
- The 'heritage site' consists of a Rocklands community hall, the library, and a memorial square (in front of the community hall).
- The proposed boundary as presented excludes the library and the memorial square.

#### RECOMMENDATION

- The committee has resolved to continue with the process of nomination in terms of \$27(8) of the NHRA and notify all interested parties and give them 60 days to make submissions regarding the proposed nomination.
- The committee further recommends to include the library, the memorial square and the community health care centre in the proposed boundaries of the declared area.

The due process as prescribed in terms of Section 27(8)(b) of the National Heritage Resources Act (NHRA, Act 25 of 1999) should be followed and all Interested & Affected Parties should be notified. This letter is therefore sent to you to inform you that the above site is proposed to be nominated as a Provincial Heritage Site in terms of Section 27(6) of the National Heritage Resources Act (NHRA, Act 25 of 1999).

The committee further recommended to include the library and the community health care centre in the proposed boundaries of the declared area.

You are allowed 60 days in terms of Section 27(8)(c) in order to make submissions regarding the proposed declaration, its amendment or its withdrawal, and in the case of the owner, to propose conditions under which the action will be acceptable.

Please address all submissions to the case officer mentioned above, within 60 days of this notification. The nomination documentation is attached for your perusal.

By virtue of the powers vested in Heritage Western Cape, a Provincial Heritage Resources Authority for the province of the Western Cape, in terms of Section 27(2) of the National Heritage Resources Act, Act No. 25 of 1999, archaeological and palaeontological sites, unmarked burials, the landscape and natural features of cultural significance and structures situated on or at Erf 11553, including the Rocklands Community Hall, the Library, the Memorial Square and the Community Health Care Centre thereon, situated on the corner of Lancaster Road and Parker Street, Rocklands, Mitchell's Plain and as reflected in the below schedule, are hereby formally protected under Section 27 of the National Heritage Resources Act 25 of 1999, bearing in mind the provisions of Sections 34, 35 and 36 of the Act.

In terms of section 27 of the National Heritage Resources Act, No. 25 of 1999, Heritage Western Cape hereby declares Erf 11553, including the Rocklands Community Hall, the Library, the Memorial Square and the Community Health Care Centre thereon, situated on the corner of Lancaster Road and Parker Street, Rocklands, Mitchell's Plain, fully described in the schedule, as a Provincial Heritage Site.

The demarcation of the Provincial Heritage Site is as follows:

Erf 11553, including the Rocklands Community Hall, the Library, the Memorial Square and the Community Health Care Centre thereon, situated on the corner of Lancaster Road and Parker Street, Rocklands, Mitchell's Plain, as described in SG Diagram No. 47/81.

Mitchell's Plain was established in the 1970s as a township to respond to the housing shortages of the coloured community. Its design was also part of the apartheid's race-based spatial planning and Group Areas Act. As forced removals intensified in Cape Town, Mitchell's Plain became a home for communities that were displaced from District Six.

Erf 11553, including the Rocklands Community Hall which was built during the early 1980s, provided a convenient space for mass resistance and large scale political gatherings that were organised by the anti-apartheid organisations. The historical meeting of 20 August 1983 which led to the establishment of the United Democratic Front (UDF) was held at this location. UDF became the largest socio-political movement that united South Africans from diverse backgrounds to fight against apartheid. The site has significant political, as well as social significance.
