**PROPOSED S-KOL SOLAR PV FACILITY AND ASSOCIATED INFRASTRUCTURE ON A  
SITE NEAR KEIMOE, NORTHERN CAPE PROVINCE**

**NOTIFICATION OF AMENDMENT TO AUTHORISATION BY DEA FOR PROJECT  
REFERENCE 12/12/20/2230**

Networx S28 Energy (Pty) Ltd obtained an authorisation for the construction of a 200MW Solar PV facility and associated infrastructure on a site near Keimoes, Northern Cape Province (DEA Ref No: 12/12/20/2230) in July 2012. The project is known as the S-Kol PV Facility.

In terms of Condition 5 of the Environmental Authorisation and Regulation 39 (1) of the EIA Regulations, an application for amendment was made to DEA for the following:

1. Change of Applicant contact details.
2. A change in the phasing of the project from:
  - Phase 1 - 30 MW;
  - Phase 2 – addition of 70 MW to increase the capacity to 100 MW;
  - Phase 3 – addition of 100 MW to increase the capacity to 200 MW.To two phases of 100MW each

In terms of Regulation 10(2)(a), the applicant hereby advises registered interested and affected parties on this project that the Department has approved the request for amendment of the authorisation for the project. The amended environmental authorisation (dated 03 June 2014), conditions for authorisation, as well as reasons for the decision are attached to this letter of notification. This amendment must be read in conjunction with the Authorisation dated 05 July 2012

As an interested and affected party your attention is drawn to Chapter 7 of the EIA Regulations which regulates appeal procedures. Should you wish to appeal any aspect of the decision by DEA, you must lodge a notice of intention with the Minister within twenty (20) days of the date of the decision.
