The reason for the exhumation of the grave it's because graves are relocated by the mining activities that are taking place in that area and the (22) known graves might be affected by the activities. Therefore the permission is granted on condition that:

- 1. A registered undertaker must handle the exhumation;
- 2. The proceedings must take place in such a manner that no offence is given, nor is there any danger to public health;
- 3. Under no circumstances may the coffin be opened;
- 4. The necessary authorities must be notified at least seven (7) days before the exhumation take place;
- 5. The remains must be sealed in an airtight container and placed in a sturdy non-transparent coffin;
- 6. Any regulations promulgated by the cemetery-authorities must be complied with and;
- 7. (Mr S Mathibela at 082 741 8755) the Chief Environmental Health Manager Nkangala District ) must be notified at least seven (7) days before the exhumation take place
