- (c) bring onto or use at a burial ground or grave referred to in paragraph (a) or (b) any excavation equipment, or any equipment which assists in the detection or recovery of metals.

Of the 14 graves located here, no Next of Kin have come forward to represent the graves and as such no written requests for their relocation were obtained.

TOP 22

Of the 3 graves located here, no Next of Kin have come forward to represent the graves and as such no written requests for their relocation were obtained.

This site has an Anglo Boer War origin (1899 - 1902), as indicated by the headstone, and is therefore very significant. Two of the graves are unidentifiable (no headstone or the headstone has no inscription). One of the graves is stone packed and the 2nd is stone packed with an unmarked sandstone headstone. The third grave has a polished granite headstone with a granite border and belongs to Johannes Jacobus Bezuidenhout from Bethal, born 25 April 1864. He died in battle at Doornkraal on 12 July 1901.

Of the 4 graves located here, all the graves have been identified and claimed by the next-of-kin, the Mahlungu family.

TOP 32

Of the 1 grave located here, no Next of Kin have come forward to represent the graves and as such no written requests for their relocation were obtained.

11. Evidence for date of grave(s):

TOP 5B

Despite our exhaustive attempt to identify and contact the family, we have no further information regarding these 14 graves. None of the graves have inscribed headstones. As such, it is assumed that all these graves are older than 60 years and relocated to until such time that evidence can be found to the contrary.

TOP 22

Despite our exhaustive attempt to identify and contact the family, we have no further information regarding these 3 graves. Apart from the marked Boer grave the graves do not have inscribed headstones. Hence, it will be assumed that both these graves are older than 60 years until such time that evidence can be found to the contrary.

TOP 23

The four graves located here have both been claimed by relatives who gave the respective dates of 1937, 1945, 1946 and 1946. This means that all graves are older than 60 years.

TOP 32

Despite our exhaustive attempt to identify and contact the family, we have no further information regarding this grave. Hence, it will be assumed that this grave is older than 60 years until such time that evidence can be found to the contrary.




Plate 3 Image showing the position of the four cemeteries in context with the landscape.

14. Purpose of and reasons for application:

The four (4) cemeteries were identified during heritage surveys and heritage impact assessments undertaken on the farms Boshmansfontein 12 IS, Makoupan 590 IS, Klipplaat 14 IS and Tweefontein 13 IS. The four cemeteries are located within the mining expansion plan known as the second phase of the Tweefontein Optimization Project (TOP).

D. PREREQUISITES FOR PERMIT

17. Please indicate what arrangements have been made for the exhumation and re-interment of the contents of the grave(s)(provide documentation and details):

At the time of this permit application, 6 of the 22 graves from the affected cemeteries had been identified by the families of the deceased. In the written permissions provided for the relocation of these identified graves, the

affected families have indicated the place of reburial for each one of their graves. These requests are summarized in the table below.

For 17 of the 22 graves located within these seven cemeteries, despite exhaustive social consultation processes, no families were identified. With no families forthcoming, the 17 graves will be relocated to either Komdraai or Kriel Cemetery which is administered by the Emalahleni Local Municipality

On Wednesday, 18 September 2013 a letter was emailed to the Station Commander of the South African Police Services of Emalahleni, informing the SAPS of the proposed relocation. The letter provided background on the proposed relocation and also requested permission for it to take place. On the same day a letter was emailed to the Emalahleni Local Municipality. A letter was received from Constable M.T. Kokhutsa on 10 October 2013, indicating that the SAPS have no objection to the proposed relocation (Addendum D).

18. Please give details of consultation with communities and individuals who by tradition has an interest in the grave(s), and of the agreement reached with such communities and individuals (as required by Act 36 and the relevant Regulations Chps IX and XI)(provide documentation and details):

We have conducted an intensive process of social consultation in order to identify the buried individuals and to obtain permission for exhumation and re-interment from the affected families, communities and other *bona fide* interested and affected parties. This process started in 2011 where some of the cemeteries were not affected. However, as developments have progressed certain cemeteries are now affected. The social consultation process recommenced on Monday, 21 August 2013 with the erection of bilingual (English and isiZulu) site notices at all the cemeteries. Bilingual (isiZulu and English) newspaper notices were published in the Daily Sun on the 18 September 2013 and Witbank News on Friday, 6 September 2013 (Addendum F) Between 19 to 25 November 2013 a radio notice was aired on SABC Ligwalagwala FM radio in the Witbank area (Addendum G).

The physical social consultation process commenced on Monday, 2 September 2013 and the methodology followed in terms of this consultative process comprised the following:

- Identification of persons who may have resided in the study area by speaking to elderly people who have lived within the surroundings of the study area all their lives.
- During conversations with these individuals leads may have been forthcoming of families or individuals who used to reside within the study area.
- Our social consultant visited each of the leads, to ascertain whether these individuals would have graves buried within the study area. In some cases preliminary meetings could immediately take place, while in others a preliminary meeting date was scheduled.
- Once families with graves within the study area had been identified, a preliminary meeting took place to introduce PGS as well as the proposed relocation project to the families. This first meeting also aimed to establishing where the graves of the particular family are located.
- Once the family representatives with whom the preliminary meeting had been held had discussed the proposed relocation with the rest of their families, a date was scheduled on which the physical identification of the graves could be undertaken and if the family so wishes the proposed request forms were signed.
- On the above date the respective family representatives were physically taken to the cemeteries where their graves were buried. The representatives then identified their graves and the respective (unique) grave numbers were recorded by the social consultant. At this point those families willing to sign the permission were then given the opportunity to do so.

The social consultation process will continue until the project has been completed.

Overall 26% of the total 22 graves have been positively identified by the affected families and written permissions provided for their relocation. The low identification rate is assumed to be because of the age of the cemeteries.
