Cease Works Order on construction activities related to Samy's Wholesalers Extension, (Erf 44500) on the corner of Quinn and Lawrence Streets, Kimberley, Northern Cape

It has come to the attention of the South African Heritage Resources Agency, "SAHRA" a public entity listed in terms of the provisions of the Public Finance Management Act 1 of 1999 and established by section 11 of the National Heritage Resources Act 25 of 1999 (NHRA), with Head Office located at 111 Harrington Street, Cape Town, 8000; that the activity on Erf 44500, at the corner of Quinn and Lawrence Street (Samy's Wholesalers Extension), Kimberley, Northern Cape is in contravention of section 36 (3) of the National Heritage Resources Act 25 of 1999.

PLEASE TAKE FURTHER NOTICE that you are hereby served with an Order in terms of section 50 (10) of the National Heritage Resources Act for any activity on Erf 44500 at the corner of Quinn and Lawrence Street, Kimberley, Northern Cape to cease immediately.

SAHRA requires that a full Heritage Impact Assessment that meets SAHRA Minimum Standards for Impact Assessments. The report by G&A Management Consultants does not meet SAHRA minimum standards for impact assessments. The new study must include social consultation. No construction

activities will be allowed until such time that SAHRA is satisfied with the new Heritage Assessment and formal communication is provided regarding the desirability of the proposed development and compliance with relevant provisions of the National Heritage Resources Act 25 of 1999.

Failure to comply with this Order could result in you and your representatives being prosecuted in accordance with provisions of the NHRA.
